PLAN OUTLAY

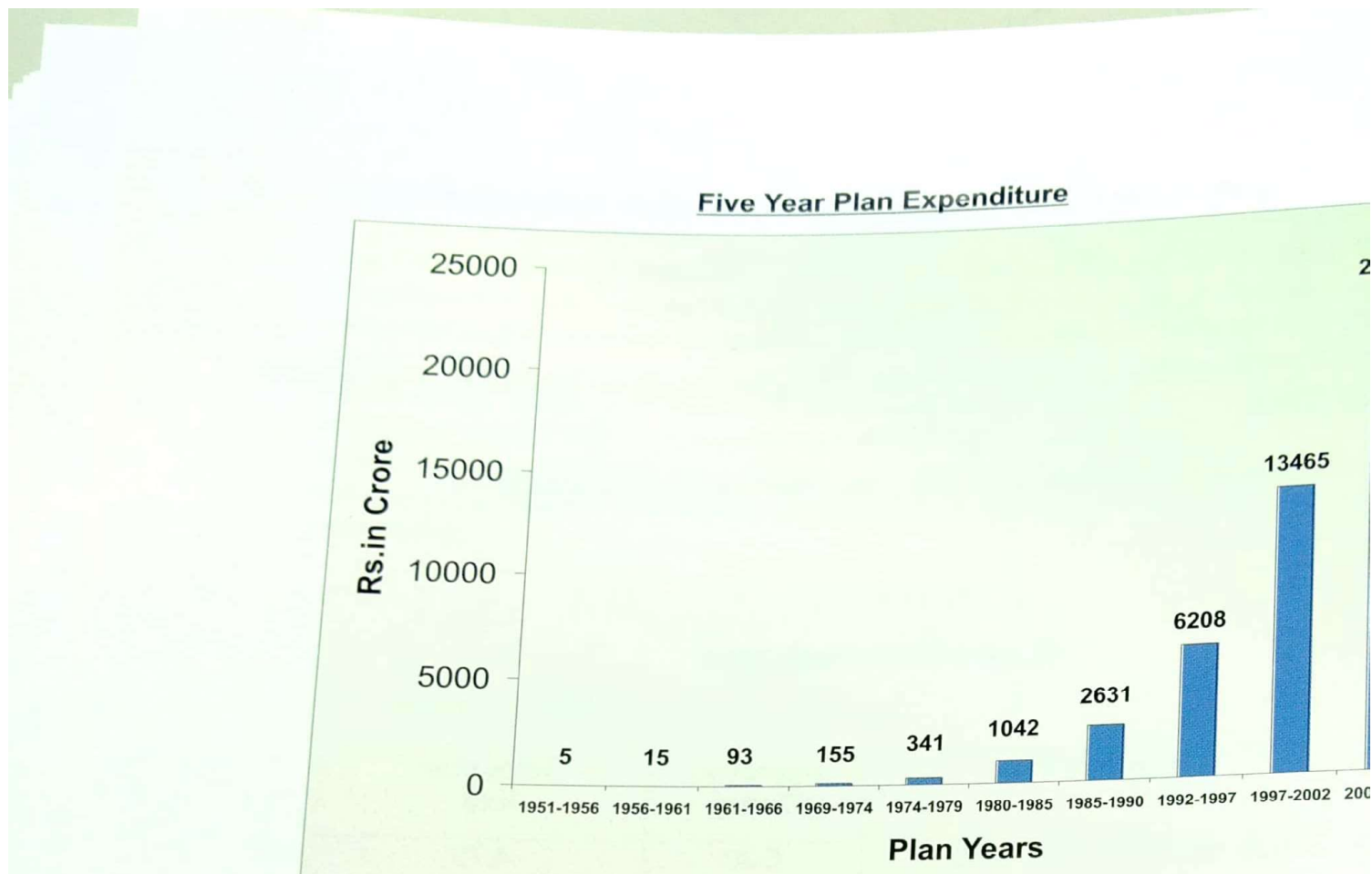
1. The Plan of the Government of N.C.T. of Delhi is financed broadly on the pattern of non-special category States.
2. The Plan outlay and expenditure under various Five Year Plans are indicated below: -

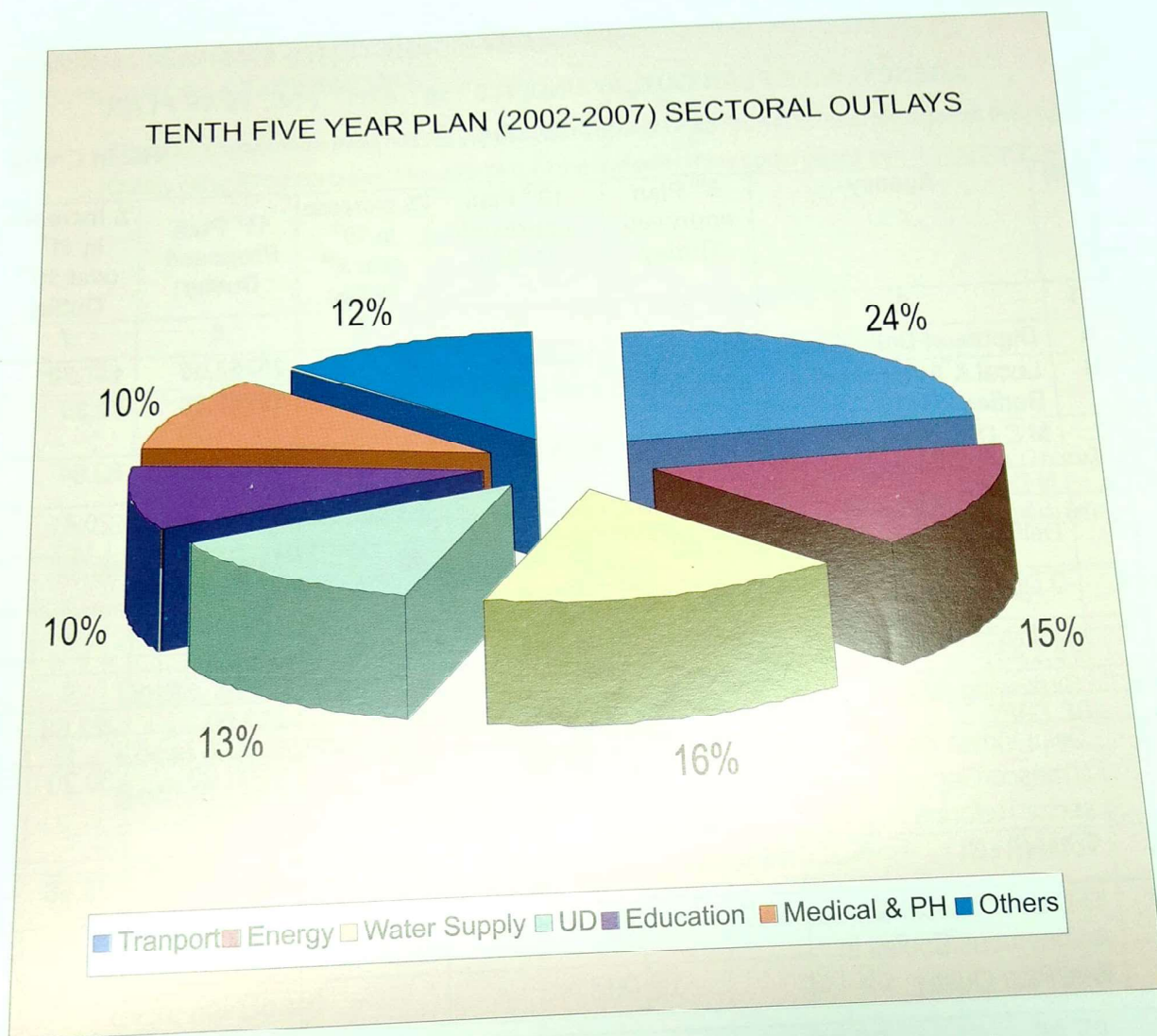

7. As against 58.04% outlay in the Ninth Plan Outlay (1997-02), the Local and autonomous bodies have been allocated 48.57 % of the 10th Plan Outlay (2002-07). As mentioned above, reforms in power sectors have led to substantial saving in Plan allocation for the power sector. This has helped to allocate plan fund to other sectors.
