- 2. Further, consequent upon the extension of their ad-hoc promotion to the post of Assistant Director (Plg./Stat.), the above mentioned officers shall continue in their present departments.
- 3. The aforesaid extension of adhoc promotion to the post of Assistant Director (Plg./Stat.) is subject to the following conditions:
 - i) The ad-hoc promotion to the post of Assistant Director (Plg./Stat.) shall not bestow on the officers any claim to regular promotion to the grade.

- ii) The promotion is being made purely on ad-hoc basis and the ad-hoc promotion will not confer any right for regular promotion.
- iii) The service rendered on ad-hoc basis in the grade of Assistant Director (Plg./Stat.) would not count for the purpose of seniority in that grade or for promotion to the next higher grade.
- iv) The ad-hoc promotion shall not confer any right on the officers to continue in the grade indefinitely and may be terminated at any point of time without giving any reasons thereof.
- v) This extension of ad-hoc promotion is only for a period of six months or till the time posts are filled up on regular basis, whichever is earlier. The Government reserves the right to cancel at any time the ad-hoc promotion and revert the government servant to the post from which he/she was promoted.
- vi) Consequent upon the expiry of six months from the date from which extension is granted, the above mentioned officers shall automatically be reverted to the post of Statistical Officer (Plg./Stat.) and shall draw their salary against the vacant posts of Assistant Director (Plg./Stat.) in their respective departments.
- vii) The ad-hoc promotion will remain subject to the outcome of the SLP (C) No. 6915/2014 & SLP (C) No. 031288/2017 and other connected cases before the Hon'ble Supreme Court.
