The Hon' Lt. 2. The officers promoted on Adhoc basis shall have no claim on seniority or for regular promotion to the grade or equivalent post. The Government reserves the right to cancel the Adhoc promotion anytime and revert the Government servants to the post from which they got promoted.

3. Consequent upon the promotion on adhoc basis to the Grade of Joint Director (Plg./Stats.), the following transfer/ posting is hereby ordered as under:-

5. The aforesaid adhoc promotion to the post of Joint Director (Plg./Stat.) is subject to the following conditions:
- The Ad-hoc promotion is subject to vigilance clearance from the department where the officer is working and after ensuring that no disciplinary proceedings are pending or contemplated against the officers. In case of pendency of such proceedings, the matter may be reported to Cadre Controlling Unit, Planning Department.
 - The promotion of Ad-hoc basis is effective from the date of assumption of charge of the post of Joint Director (Plg./Stat.) by the officer concerned in the department to which he/she has been posted.
 - This ad-hoc promotion shall be initially for six months or "until further orders" whichever is earlier. The Government reserves the right to cancel at any time the ad-hoc promotion and revert the government servant to the post from which he/she was promoted.
 - The ad-hoc promotion to the post of Joint Director (Plg./Stat.) shall not bestow on the officers any claim to regular promotion to the grade.
 - The service rendered on ad-hoc basis in the grade of Joint Director (Plg./Stat.) would not count for the purpose of seniority in that grade or for promotion to the next higher grade.
 - The ad-hoc promotion shall not confer any right on the officers to continue in the grade indefinitely and may be terminated at any point of time without giving any reasons thereof.
