ORDER NO. 23/2018

The Hon' Lt. Governor, Delhi has accorded approval for Ad-hoc promotion of the Sh. Ganesh Singh Rawat, Deputy Director (Plg./Stat.), Group 'A' Gazetted in the Pay Scale of Level-11 of Pay Matrix to the post of Joint Director (Plg./Stat), Group 'A', Gazetted in the Pay Scale of Level-12 of Pay Matrix in the Planning and Statistical Cadre, Govt. of NCT of Delhi for a period of six months or until further orders whichever is earlier, with immediate effect.

2. Consequent upon his promotion to the post of Joint Director (Plg./Stat.) on adhoc basis, Sh. Ganesh Singh Rawat shall continue to work in Urban Development Department on diverted capacity from Planning Department, Govt. of NCT of Delhi with immediate effect.

3. The officer promoted on Adhoc basis shall have no claim on seniority or for regular promotion to the grade or equivalent post. The Government reserves the right to cancel the Adhoc promotion anytime and revert the Government servants to the post from which they got promoted.

4. The aforesaid adhoc promotion to the post of Joint Director (Plg./Stat.) is subject to the following conditions:

- i) The Ad-hoc promotion is subject to vigilance clearance from the department where the officer is working and after ensuring that no disciplinary proceedings are pending or contemplated against the officers. In case of pendency of such proceedings, the matter may be reported to Cadre Controlling Unit, Planning Department.
- ii) The promotion of Ad-hoc basis is effective from the date of assumption of charge of the post of Joint Director (Plg./Stat.) by the officer concerned in the department to which he/she has been posted.
- iii) This ad-hoc promotion shall be initially for six months or "until further orders" whichever is earlier. The Government reserves the right to cancel at any time the ad-hoc promotion and revert the government servant to the post from which he/she was promoted.
- iv) The ad-hoc promotion to the post of Joint Director (Plg./Stat.) shall not bestow on the officers any claim to regular promotion to the grade.
- v) The service rendered on ad-hoc basis in the grade of Joint Director (Plg./Stat.) would not count for the purpose of seniority in that grade or for promotion to the next higher grade.



3. This issues with the approval of Competent Authority.


