The officers concerned may be allowed to exercise their options if any under FR 22 within one month of the issuance of the order granting the financial up-gradation under the Modified Assured Career Progression Scheme to their Administrative Department directly.

The concerned Head of the departments are requested to issue formal order for grant of the financial up-gradation in respect of the above mentioned officials working in their department. However, before the issuance of the formal order the Heads of the Departments may again confirmed that these officers have completed 20 years regular service since the date of their initial appointment and are clear from the Vigilance angle.
