**ORDER NO. 39/2012**


The officers concerned may be allowed to exercise their options if any under FR 22 within one month of the issuance of the order granting the financial up-gradation under the Modified Assured Career Progression Scheme to their Administrative Department directly.

However, the grant of higher Pay Scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.

The Head of the Department concerned is requested to ensure before issuing the final order that 20/30 years regular service of the officers does not include the period of service rendered in State Government/Statutory body Autonomous body/Public sector Organizations the period of past service in these bodies is not counted for grant of financial up-gradation under MACP Scheme. (Point No. 10 of DoPT OM dated 19.05.09).

The concerned Head of the departments are requested to issue formal order for grant of the financial up-gradation in respect of the above mentioned officials working in their department. However, before the issuance of the formal order the Heads of the Departments may again confirmed that these officers have completed 20/30 years regular service since the date of their initial appointment and are clear from the Vigilance angle.


