#### **CHAPTER - 11**

### **JAIL**

The administration of Jails in Delhi has been mandated with Home Department, Government of NCT of Delhi as per Allocation of Business Rules, 1993.

Delhi Prisons has three Prison Complexes, one at Tihar being one of the largest prison complex in the world comprising of nine Central jails and second is Central Prison at Rohini having one jail and third is Mandoli Prison Complex having 6 Central Jails. The total population in sixteen prisons is around 15468 prisoners against the sanctioned capacity of 10026 prisoners (6250 of Tihar & Rohini and 3776 of Mandoli).

In order to decongest the existing Tihar Prisons, Mandoli Prison Complex with six Jails has been setup. There is also a proposal to construct new jails at Narela and Baprola.

With a view to reforming the prisoners and enabling them to start a normal and financially rewarding life after release, the prison administration has started several reform and correctional measures. The prisons are undertaking various activities including adult education, formal education, games, counseling, law, health, vocational, meditation, reformation, factories production. The prison administration has provided facilities for education of inmates by getting affiliated with the Indira Gandhi National Open University and the National Open School.

As a part of community participation in the reformation and social integration of prisoners after release, a large number of respectable members of non-governmental organizations, retired Major Generals, Professors of I.I.T. Delhi, Eminent Psychiatrists, Psychologists, Principals and Teachers of various educational institutions have been conducting various activities in the jail. These programmes have very sobering and positive impact on the psyche of the prisoners, who have been shown the positive and constructive approach to life after interaction with them. Some of the NGOs have trained selected prisoners on various trades and have been bringing job for them against payment of remuneration. They also rehabilitate these prisoners after their release. It shows that force is always not necessary to control and correct the prison inmates. The manner in which the Tihar administration has taken up the system of rehabilitation, it becomes important for other prisons of the nation to follow suit.

Various trades are taught to convicts in the Jail Factory itself. Taking this objective a step forward, there is a Jail Factory with state-of-the-art machinery. A diverse range of products are manufactured in the factory with the use of best quality ingredients. The items are produced in the most hygienic conditions. This gives products a touch of excellence. TJ is a unique brand with a wide range of products which are manufactured by the prison inmates in Tihar Jail Factory. TJ's has a variety of products such as Bakery products, Handloom & Textile, Apparel, Furniture, Pure Mustard Oil, Recycled hand-made paper products, paintings, designer candles & lamps, Jute bags, herbal products and many more.

The space congestion has created problems of health, hygiene, sewerage, management control, discipline etc. All efforts are, therefore, being taken to construct new jails. In order to decongest the existing prisons there is a plan to construct new jails at Narela and Baprola. The Mandoli Jail complex has been inaugurated on 05 March 2019.

Major Project/Program/Scheme details and their Budget Outlay for the year 2020-21 are as under:

## 1. Construction of District Jail at Mandoli, Shahdara (Mandoli Prison Complex)

Annual Outlay : ₹ 300 lakh (Capital)

Aims and Objectives of the Scheme	:	To decongest the existing jails and to accommodate more prisoners (3776).

### 2. Motor Vehicle

Annual Outlay : ₹1500 lakh (Capital)

Provision of ₹1500 lakh has been made available for fulfilling the need of motor vehicle for new jails and existing jails and procurement of second phase of Ambulances.

### 3. Machinery and Equipments

Annual Outlay : ₹450 lakh (Capital)

Aims and Objectives of the Scheme	••	The basic objective of the scheme is to purchase security equipments like CCTV / Cellular Jammer System, Scanners to strengthen the security arrangements.
Physical Target	:	In addition to the existing system, CCTV / Cellular jammer System, Scanner, Computers, Camera and various other office items to be purchased and installed in all Prisons for smooth functioning.

#### Proposed Activities under the scheme:-

To improve and strengthen the security system in Tihar Jail Complex (Houses 9 Jails), Distt. Jail Rohini and Mandoli Jail Complex (Houses 6 Jails) so that the smuggling of prohibited items like surgical blades, tobacco, narcotics, knifes, mobile phones etc. can be stopped. The details of various security equipments are as under:

- Cell Phone Jammers: For security measure, there is requirement of installation of jammers in each jails.
- X-Ray Baggage Scanner Machines: For security purpose of screening the articles brought into the jails by the prisoners, there is a proposal for purchase of X-Ray baggage scanners.
- X-Ray based Full Human Body Scanners: The Prisons authorities are facing security problems as number of inmates are indulging in smuggling of prohibited items like Cell Phone, Blades, knife, narcotics etc, in their body cavities. For the purpose there is a proposal of installation of X-Ray based Human Body Scanners.
- Multizone Door Frame Metal Detector (MzDFMD): Each person is required to be searched thoroughly at the time of entry in the jail. For the purpose, MzDFMDs are required to be installed for detecting smuggling of prohibited items.
- Deep Search Metal Detector: For search of prohibited items concealed under the earth and in wall, there is need for Deep Search Metal Detector. There is a proposal of procurement of Deep Search Metal Detector.
- Hand Held Metal Detectors (HHMD): At the time of physical checking of inmates, HHMDs are required for the purpose.

## 4. Implementation of e-Prisons projects (CSS)

Annual Outlay : ₹150 lakh (Revenue)

CSS scheme "Implementation of E-prisons project" aimed at computerization of the functioning of all prisons in the NCT of Delhi including digitization and availability of prisoner's data in an electronic platform.

As per MHA, GOI and prisons of several States/UTs have taken steps towards computerization of prison management processes. The M/o Home Affairs, GOI has decided to implement the E-prisons project which aims at computerization of the functioning of all prisons in the country, including digitization and availability of prisoner's data (convicts, undertrials, detainees etc.) in an electronic platform which will be accessible to designated authorities of Central and State Govts. The objective of this project is to create end-to-end IT solution for automation of prison operations. The Central Govt. will provide financial assistance and technical support to States and UTs for implementation of the project in the form of software application, IT hardware, connectivity, customisation etc. As per MHA, the funds allocated will be used by the NCT of Delhi for creation of ICT set up in all Prisons of the NCT of Delhi in consultation with NIC. The NCT of Delhi will transfer the above amount to the concerned Department / implementing agency responsible for implementation of E-prisons project in all prisons of the NCT of Delhi. The automation of Delhi Prison system needs the up-gradation of present hardware and software infrastructure.

## 5. Installation/O&M of CCTV Surveillance System in all Jails Annual Outlay : ₹2500 lakh (Capital)

The Supply, Installation, Testing and Commissioning of CCTV Surveillance System at Tihar, Mandoli and Rohini Prison Complex through PWD at an Preliminary Estimated (PE) cost of ₹119.69 crore approx. was submitted by Home Department. Time required for completion of this project is 10 months.

As per Administrative Department the project is being taken up in compliance of directions issued by Hon'ble High Court order dated 15.10.2018 regarding installations of 5692 CCTV cameras in Tihar, Mandoli and Rohini prison complex, recruitment of jail staff and staffing of technical wing.

# 6. Developmental Works in Central Jail Tihar & Distt. Jail Rohini Annual Outlay : ₹3000 lakh (Capital)

The objective of the scheme is to carry out various developmental works like construction of roads, accommodation, electricity, drinking water, sewer lines, construction of barracks, sanitation services etc. in the Tihar and Rohini Jail Complex.
