

## Chapter -12

### **PUBLIC WORKS**

Public Works Department is implementing various projects and schemes for construction of new Buildings both for Delhi Govt. Offices & for Court Building also. Apart from this, it also executes renovation/addition/alteration of Delhi Govt. Offices. The approved budget for Construction/Renovation works of various Govt. Departments are placed with Public Works Department for this purpose. The budget allocation in the Public Work sector does not include huge capital investment made in other Sector/major Departments like Education, Medical & Public Health, Transport, Revenue, Jail, Fire etc.

## 2. COURT BUILDINGS

Annual Outlay 2020-21 : ₹ 18000 Lakh

[₹ 4000 Lakh (Rev. for repair & maintenance) + ₹ 14000 Lakh (Cap. including CSS)]

### a. Repair & Maintenance of various Court Buildings

Annual Outlay : ₹ 4000Lakh (Rev.)

Budget provision under revenue section for improvement / up-gradation / alteration of the existing various Court Buildings for better working environment for Judiciary.

### b. Capital Works of various Court Buildings

Annual Outlay : ₹ 14000 Lakh (Cap. including ₹ 10000 Lakh CSS)

## 3. Installation/Erection of Hoarding Structures on Delhi Govt. Buildings/ Premises for Govt. Advertisements

Annual Outlay 2020-21 : ₹ 200 Lakh (Cap.)

A proposal for erecting 949 hoarding structures on the pattern of Rent Free Sites in the premises of Delhi Govt. Offices/Hospitals/Schools etc. all over Delhi for Government Advertisements was initiated by Directorate of Information & Publicity (DIP), GNCTD. All Govt. schools, hospitals and other public offices for erecting structure on the pattern of Rent Free Sites, which can be managed and used for various Govt. campaigns on a regular basis. PWD to take up the installation on a centralized basis so as to ensure quality and economy. Once installed DIP can get all Delhi Govt. outdoor campaigns mounted on these structures.

#### **4. Repair and Maintenance of Directorate of Home Guards Building**

Annual Outlay 2020-21 : ₹ 70 Lakh (Rev.)

Budget provision under revenue section of PWD is for repair and maintenance of the existing Directorate of Home Guards office building for better working environment.

#### **5. Repair and Maintenance of Registrar Cooperative Societies Office Building**

Annual Outlay 2020-21 : ₹ 30 Lakh (Rev.)

Budget provision under revenue section of PWD is for repair and maintenance of the existing Registrar Cooperative Societies office building for better working environment.

#### **6. WEIGHTS & MEASURES DEPARTMENT**

Budget Allocation 2020-21 : ₹ 60 lakh

Construction of six number of Standard Laboratory and One Second Standard Laboratory and Controller Office at Karkardooma. Renovation of existing office building.

#### **7. LABOUR DEPARTMENT**

Budget Allocation 2020-21 : ₹ 15 lakh

Renovation of Labour welfare centres and district offices being run by department in different parts of Delhi.

#### **8. DIRECTORATE OF EMPLOYMENT**

Budget Allocation 2020-21 : ₹ 50 lakh

Construction of building of Employment Exchange and renovation / repair of existing building of Employment Exchange.

## 9. DEPARTMENT OF ARCHIVE

Budget Allocation 2020-21 : ₹ 200 lakh

The Department has proposed the following works under capital head during 2020-21 for strengthening of the Archives Department.

### i. Construction of Cultural Complex at 18-A, Satsang Vihar Marg, New Delhi- 110067 :-

- i. The existing storage space for housing the important archival records are almost exhausted and lot of records are lying on the floor of the stack due to non-availability of space, which is against the archival principles. Further, lot of records of Govt. of NCT of Delhi are transferred to the Department for proper housing that is an important duty assigned to the Department. The Department proposes construction of this block on priority basis along with the provision of Conference Hall, Auditorium, Art Galleries etc. for the common use of the Departments of Govt. of NCT of Delhi.
- ii. Repairing of Stack Block on account of structural failure at Delhi Archives building.
- iii. Provision of fire walls and other preventive measures under the guidance of Delhi Fire Services to protect the records from fire hazards.
- iv. Provision of eco friendly fire fighting system instead of Co2 flooding system
- v. Construction of building in Gadaipur ( Land under transfer from Transport Deptt)
- vi. Face-lifting of existing Administrative Block on the pattern of Stack Block
- vii. Any other civil/ electrical/ horticulture work as per requirement of the Department.
