## **Budget Highlights 2012-13**

- 1. Budget Estimates for the current year fixed at ₹ 33436 Crore
  - Plan ₹ 15000 Crore
  - Non Plan ₹ 18268 Crore
  - CSS ₹ 168 Crore
- 2. The Budget will be financed from 94% of our own resources and 6% as grant from Centre.
- 3. Out of the total proposed plan outlay of ₹ 15,000 crore, the social services sectors allocated ₹ 9796 crore, accounting for 65% of the total plan outlay in 2012-2013 as compared to 59% in 2011-2012.
- 4. GSDP at current price is ₹ 313934 Crore.
- 5. In real terms the growth in GSDP in Delhi in 2011-2012 at 11.3% far exceeds the 6.9% at the national level.
- 6. The contribution of Delhi to the national level GDP is about 3.8%, while the share of Delhi in the total population of the country is 1.4%.
- 7. The per capita income in 2011-2012 in Delhi is estimated to be ₹ 1.76 lakh as against the national level figure of ₹ 60972.
- 8. The proposed target in the current fiscal year for tax collection is ₹ 26150 crore. This would represent a growth of 31% over the tax collection of ₹ 19972 crore in 2011-2012.
- 9. Outstanding loan, which was ₹ 30140 crore as on March 31, 2011 has been reduced to ₹ 29608 crore as on March 31, 2012.

- 10. 'Dilli Annashree Scheme' will be launched by the Government.
- 11. Under 'Dilli Annashree Scheme' two lakh vulnerable households would be provided the food subsidy of ₹ 600 per month as cash transfer to senior most female member / household. With this, government shall be able to cater substantially to the needs of the poor in the spheres of *roti*, *shiksha*, *and swastha*. An outlay of ₹ 150 crore proposed in the budget.
- 12. Delhi to be made a Kerosine Free City and Government to provide one time cash subsidy of ₹ 2000 to about 1.75 lakh households for obtaining an LPG connection and purchase of a gas stove. An outlay of ₹ 40 crore proposed in the current year.
- 13. An 'educational hub' proposed to be setup at Bakkarwala.
- 14. 'Dilli Swarojgar Yojana for SC/ST/Minorities/OBCs to be launched to provide loan upto ₹ 5 lakh to an entrepreneur willing to set up a venture in Delhi.
- 15. About 150 Anganwadi centers, 15 new Gender Resource Centers (GRC) for women in minority concentration districts will be opened. The physical infrastructure and learning environment in all Urdu medium schools will be improved. Through Mission Convergence, 10 new centers for capacity building of unemployed minority youths will be started to promote employment avenues.


- 16. Construction of hospitals at Burari, Ambedkar Nagar, Hastsal, Siraspur, Madipur, Sarita Vihar and Dwarka will be started.
- 17. Improved Immunization cover for children will be started by providing pentavalent vaccine which is a 5 in 1 vaccine for diphtheria, pertusis, tetanus (DPT), hepatitis B and haemophilus influenza Type B.
- 18. Government has decided to give financial assistance of ₹ 1000 per month to poor persons suffering from HIV/AIDS for antiretroviral treatment. Orphaned children infected with HIV/AIDS will be given ₹ 2050 per month and those affected by HIV/AIDS ₹ 1750 per month.
- 19. Government have constituted Delhi Arogya Kosh with a corpus of ₹ 110 crore in 2011-2012. Eligibility income level increased from the existing ₹ 1 lakh to ₹ 2 lakh to benefit more needy persons.
- 20. To setup 100 dialysis machines in various parts of Delhi under PPP mode.
- 21. A cash subsidy for purchase of writing material/stationery of ₹ 300 per annum to students of Class I to V and ₹ 400 per annum to students of Class VI to VIII students in government and government-aided schools.
- 22. Common services and facilities in 'kataras' will be improved and DUSIB to be provided ₹ 5 crore for this purpose.


- 23. Budget provision for 'My Delhi I Care Fund Program' increased from ₹ 5 crore in 2011 -2012 to ₹ 45 crore in 2012-13 so that large number of developmental works can be taken up in each colony.
- 24. Government has decided to grant of confirmed ownership rights to the original allottees in about 44 JJ Resettlement colonies. Necessary recommendation is being made to Government of India.
- 25. For development of Urbanized and Rural villages an amount of ₹ 53 crore and ₹ 192 crore respectively provided.
- 26. Financial support to each 2000 Eco-clubs will increase from ₹ 10,000 to ₹ 20,000 in the current financial year.
- 27. Knowledge-based Industrial Park near Baprola in an area of about 77 acres at a cost of ₹ 1800 crore will be developed.
- 28. A Green Field World Class Skill Up-gradation Centre is proposed to be developed at Jaunapur in collaboration with Government of Singapore.


## Highlights of PART - B TAX - PROPOSALS

- 1. Exempted the recently announced increase in the price of petrol from the levy of VAT to give relief to the people.
- 2. To discourage consumption of tobacco and tobacco products, VAT on all these products raised to 20% from 12.5%.
- 3. Exempted all kinds of textiles costing upto ₹ 300 per metre, piece or set costing upto ₹ 600 and sarees upto ₹ 1000 to benefit the common man. All textiles above these limits shall be taxed at a 5%. Khadi to remain exempted.
- 4. VAT on cups and glasses made of plastic increased from 5% to 12.5% to discourage their use.
- 5. Blood bags exempted from VAT which is currently taxable at a rate of 12.5%.
- 6. VAT on mahavar, hair pins, hair clips, safety pins, saree falls and juna used in kitchens exempted from VAT.
- 7. Commodities which are generally used for religious ceremonies and festivals like roli, kirpan, prasadam, sacred thread, mishri, patasha exempted from VAT.
- 8. Tricycles, kites, geometry boxes, color boxes, crayons, pencil sharpeners exempted from VAT for the benefit of children.
- A moderate levy of VAT @ 5% on CNG used in transport sector.
   Neighbouring states of UP and Haryana are already leving VAT @ 12.5% and 5% respectively on CNG.
- 10.VAT on UPS systems and their parts increased from 5% to 12.5%
- 11.VAT on plastic, rubber and Rexene footwear having MRP less than ₹ 500 per pair exempted from VAT for the benefit of Aam Aadmi.


