

JAIL

The population of prisoners is increasing each year. The space congestion has created problems of health, hygiene, sewerage, management control, discipline etc. This creates effect on human rights of inmates in jail. The National Human Rights Commission (NHRC), the High Court and the Supreme Court, time and again, have highlighted the issue for decongesting the jails. The Government of Delhi is committed to resolve this problem through the construction of new jails. In order to augment capacity of the prisons, Govt. of Delhi had planned the project for "Construction of Prison Complex including Housing at Mandoli, Delhi".

In addition, there are plans to construct jails at Narela and open jail at Baprola. For the land at Narela, part payment has been made to the DDA. The land at Baprola has been identified and draft notification for acquisition for land is under process. Two jails would be taken up for construction at these sites. After completion of all these jails, the total prisoner capacity of the jails would be about 12,000. Construction of new jails involves construction of both office as well as residential accommodations for various services like Jail Staff, Security Staff, PWD, DAP etc. and creation of posts for Jail, Administration, Medical & Health, Purchase of vehicles & various equipments etc.

Cost of Scheme	:	Initial cost Rs.168.51 crore, A new proposal has been sent for EFC approval with revised estimated cost of Rs.337 Crore.

Year of commencement / target date of completion	:	Project started in 2005 with target time of completion of Mandoli Jail is within 21 months after approval. It was design to accommodate 3776 number of prisoners and also 330 staff quarter, 594 hostel rooms and 50 bedded hospital +35 beds in 5 Nos. in medical facilities. The cost of the project is to be revised in 2011-12.

1. **Narela Prison** : The land has already been got earmarked by DDA and the amount Rs. 7,79,01,700/- for 40 acres of land had already been deposited on 31.03.2003 with DDA by this department against the earmarked land. The possession of land is yet to be handed over by DDA. Thereafter, the construction work will be done during the 12th Five year plan.

2. **Baprola Prison:** Delhi Prison Department had already made a requisition to DDA for allotment of land of the 40 acres land at Baprola but the details of the land has not been provided so far. After receiving the details of the land the cost of land of Rs.17.80 Crores approx. will be deposited with DDA and thereafter the construction work will be done during the 12th five year plan.

3. **Other Projects:**

This department had already decided to set up the Jail Training Institute, Armory, Construction of Additional Tower and renovation of old residential Quarters in the Prisons Complex in the 12th Five year Plan. The details of approximately construction cost of all four projects are as under:

- a) Jail Training Institute:- Approximately 45 Crores.
- b) Armory: Rs. 20 Lakh approximately
- c) Additional Watch Towers:- Rs 10 Lakh approx.
- d) Renovation of old Staff Quarters: Rs. 45 Crores approximately

4. **Proposed Target:**

There is a need for Modernization and Technology Enablement of Security systems in the Jails:

- Security Systems : In order to improve and strengthen the security system in Tihar Jail Complex (Houses 9 Jails) , Distt. Jail Rohini and Mandoli Jail Complex (Houses 6 Jails , to be commenced shortly) so that the smuggling of prohibited items like surgical blades, tobacco, narcotics, knives , mobile phones etc. can be stopped, various security equipments are needed for the purpose. The details of such security equipments are as under :
- 15 Small + 5 Big X-Ray Baggage Scanner Machines : There is requirement of 15 small and 5 big X-Ray baggage Scanner Machines to be installed in all the 9 jails at Tihar Jail Complex, 1 at Distt. Jail Rohini and 6 at Mandoli Jail Complex. One each baggage scanner machine is required for Jail (Factory/Stores), in Central jail Mandoli, Rohini Distt. Jail and at Main Store, CJ-1. Big X-Ray baggage scanner are required for Jail Factory and Store. The total approx. cost of these x-ray baggage scanner is Rs. 6 Crore.

- 20 Nos. of Inmate Telephone Call System : As per the Govt. Policy and orders of Hon'ble High Court, Delhi in Case , WP(Crl) No. 1151/2009 titled as Court on its own motion V/s State, telephone systems are required in each jail at 2-3 points so that prisoners can call their family members and they can be relieved of tension & depression and other

psychological problems. This will further reduced visits of family member to jails. The cost of the project would approx. be Rs. 40 Lakh.

- 15 X-Ray based Human Body Scanners : The Prisons authorities are facing security problem as number of inmates are indulging in smuggling of prohibited items like Cell Phone , Blades , knife, narcotics etc, in their body cavity. For the purpose there is urgent need of installation of X-Ray based Human Body Scanner, one in each jail. Presently there are 09 Jails in Tihar Jail Complex, 01 at Distt. Jail Rohini and 6 jails at Mandoli Jail Complex (to be commenced shortly). The total approx. cost of this equipment is around Rs. 45Crores. This equipment will be procured phase-wise as under :

- Cell Phone Jammers : For security measure, there is requirement of installation of jammers in each jails. The matter is already been pursued by Hon'ble High Court, Delhi vide, case WP(Crl) No. 1151/2009 titled as Court its own motion V/s State. Presently there is requirement of 80 Cell Phone Jammers in all the prisons in Delhi. We have already procured 10 Jammers and process of procuring of 21 more jammers is under progress. Thus there is requirement of 49 jammers (20 W) for the next five year. The total cost of these 49 jammers would approx. be Rs. 12.50 Crore.

- 15 Nos. of Deep Search Metal Detector : 15 Nos. in each jail for search of prohibited items concealed under the earth and in wall, there is need for Deep Search Metal Detector. The approx. cost of these items is around Rs. 22.50 Lakh.

- 45 Nos. of Multizone Door Frame Metal Detector (MzDFMD): Each person is required to be searched thoroughly at the time of entry in the jail. For the purpose (3 each per jail) 45 MzDFMDs are required to be installed for detecting smuggling of prohibited items. The approx. total cost of these equipment is Rs. 1.80 Crore.

- 100 Nos. of Hand Held Metal Detectors (HHMD) : At the time of physical checking of inmates , HHMDs are required for the purpose. The approx. total cost of these equipments is Rs. 1 Crore.
