2. The Officers/ Officials concerned may be allowed to exercise their options if any under FR22 within the month of issuance of the order granting the financial up gradation under the Modified Assured Career Progression Scheme However, the grant of higher pay scale is subject to the undertaking that in the event of over payment which may be detected at later stage the same will be recovered from their pay.

4. The Head or Departments concerned are requested to ensure before issuing final order that the officer/ officials does not include the period of service rendered in State government Statutory Body/ Public Sector Organization as the period of past service in these bodies is not be counted for grant of financial up gradation under MACP Scheme (Point No. 10 of DoPT OM dated 19.09.2009).

5. The concerned Head of Departments are requested to issue formal order for grant of financial up gradation in respect of above mentioned officers/ officials working in their Departments. However, before issuing formal order, again it may be confirmed that these officers/ officials have completed the required years of regular service without promotion since the initial appointment. A copy of Vigilance Status Report dated 23/06/2015 received from Directorate of Vigilance, GNCTD in r/o above mentioned officers are enclosed herewith for necessary action.
