No. No.35034/3/2008-Estt. (D) dated 19.05.2009 & 22.10.2019 of the Government of India, Ministry of Personnel, Public Grievances and Pensions (Department of Personnel & Training), the Hon'ble Lt. Governor, Delhi is pleased to grant 3rd Financial Up-gradation under MACPS to the followings eligible Dy. The grant of MACP benefits is subject to the fulfilment of conditions stipulated under DoPT OM No.35034/3/2015-Estt.(D) dated 22.10.2019 and further subject to the followings :

- There shall, however, be no further fixation of pay at the time of regular promotion if it is in the same pay level as granted under MACPS.
- Fixation of pay on grant of financial upgradation under MACPS on or after 01.01.2016 shall be made as per Rule 13 of CCS (RP) Rules, 2016 issued vide Department of Expenditure notification dated 25th July, 2016 and in terms of provisions contained in DoP&T OM No. 13/02/2017-Estt (Pay-I) dated 27.07.2017.
- The above said officers of Planning and Statistical Cadre, GNCTD concerned may be allowed to exercise their options, if any, under FR 22 within the month of issuance of the order granting the financial up-gradation under the Modified Assured Career Progression Scheme.

- 4. The Concerned Head of Departments are requested to ensure before issuing formal order for grant of MACP that the official concerned has not refused regular promotion before becoming entitled to a financial up-gradation.
- 5. The Concerned Head of Departments are requested to also ensure before issuing final order for grant of MACP that the official concerned does not include the period of service rendered in State Government/Statutory Body/Public Sector Organisation as the period of past service in these bodies is not be counted towards Regular Service (Point no 10 of DoPT order dated 22.10.2019).
- 6. The grant of higher pay scale is subject to the undertaking that in the event of over payment which may be detected at later stage the same will be recovered from their pay.
- 7. It should be ensured by concerned Head of Department, GNCTD that the above mentioned official have completed the required years of regular service without promotion since the initial appointment in the grade and is absolutely clear from vigilance angle at all levels and is not under currency of penalty, at the time of release of financial benefits.
- 8. The concerned Head of Department is requested to issue formal order for grant of financial up-gradation in respect of above mentioned officers after verifying and checking the service particulars with regard to date of appointment etc, as mentioned above are correct and also after ensuring that all the conditions prescribed above have been fulfilled and complied with. Discrepancy, if any, brought to the notice of concerned department, the orders in respect of such official may not be implemented till clarification under intimation to Planning Department, GNCTD.
