ORDER NO. 31/2011

1. A meeting of the Screening Committee "constituted in the Planning Department for the purpose of ACP/MACP cases" was held on 31st May, 2011 to consider review of grant of MACP cases of the eligible Statistical Assistants who were granted financial up-gradation vide Order No. 40/2010 dated 11th October, 2010.
2. It was brought to the notice of the Screening Committee that wr.t. the Planning Department's Order No.40/2010 dated 11.10.2010 for grant of financial up-gradation under MACP Scheme, there has been some cases where revision in MACP upgradation are required. It was clarified that due to restructuring of Planning & Statistical Cadre the pay scale of the officers mentioned in the list below at Snty.No.372,374,375,376,377,378,380,385 and 386 working in the pay scale of Rs.5500-9000/- were replaced with the pay scale of Rs.6500-10500/- with grade pay of Rs.4600/- w.e.f. 01.12.2006.
3. It was also brought before the Screening Committee that, in the light of said restructuring and replacement of pay scale with GP of Rs.4600/- ,the eligibility status of these said officers need to be modified for grant of MACP.
4. Accordingly, on the basis of the said clarification, the Screening Committee recommended MACP up gradation as under:

4. The officers granted MACP, vide this order may be allowed to exercise their options if any under FR 22 within one month of the issuance of the order granting the financial up-gradation under the Modified Assured Career Progression Scheme to their Administrative Department directly.

5. However, the grant of higher Pay Scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.

6. The Head of the Department concerned is requested to ensure that before issuing the formal order that regular service of the officers as specified in the MACP rules does not include the period of service rendered in State Government/Statutory body Autonomous body/Public sector Organizations, as the period of past service in these bodies is not counted for grant of financial up-gradation under MACP Scheme. (Point No. 10 of DoPT OM dated 19.05.09).

7. The concerned Head of the departments are therefore requested to issue a formal order for grant of the financial up-gradation in respect of the above mentioned officials working in their department subject to confirmation of the above condition in para 6 and along with ensuring clearance of the concerned official from the Vigilance angle.
