ORDER NO. 37/2021

The Hon' Lt. 2. The aforesaid extension of Ad-hoc promotion to the post of Assistant Director (Plg./Stat.) is subject to the following conditions:
- The Ad-hoc promotion to the post of Assistant Director (Plg./Stat.) shall not bestow on the officers any claim to regular promotion to the grade.
  - The service rendered on ad-hoc basis in the grade of Assistant Director (Plg./Stat.) would not count for the purpose of seniority in that grade or for promotion to the next higher grade.
  - The Ad-hoc promotion shall not confer any right on the incumbents to continue in the grade indefinitely and may be terminated at any point of time without giving any reasons thereof.
  - This extension of Ad-hoc promotion is only for the period mentioned above. The Government reserves the right to cancel at any time the ad-hoc promotion and revert the government servant to the post from which he/she was promoted.
  - The Ad-hoc promotion is subject to the final outcome of Original Application No. 4554/2015 filed by Shri Ashutosh Kumar & Ors vs Govt. of NCT of Delhi.
