The officers concerned may be allowed to exercise their options, if any, under FR22 within the month of issuance of the order granting the financial up gradation under the Modified Assured Career Progression Scheme However, the grant of higher pay scale is subject to the undertaking that in the event of over payment which may be detected at later stage the same will be recovered from their pay.

- The Head of Departments concerned are requested to ensure before issuing final order that the officers does not include the period of service rendered in State Government/ Statutory Body/Public Sector Organization as the period of past service (before joining Planning and Statistical Cadre) in these bodies is not be counted for grant of financial up gradation under MACP Scheme (Point No. 10 of DoPT OM dated 19.05.2009).
- 4. The concerned Head of Departments are requested to issue formal order for grant of financial up gradation in respect of officers mentioned at para no. 1 working in their Departments. However, before issuing of the formal orders, it is to be confirmed that these officers have completed the required years of regular service without promotion since the initial appointment in the service and are clear from Vigilance angle. Adhoc/temporary service period shall not be counted for grant of MACP benefits.
