On the recommendations of the Screening Committee constituted for grant of Financial Up-gradation under the Modified Assured Career Progression Scheme(MACPS) to Planning and Statistical Cadre in accordance with the instructions contained in OM No. 35034/3/2008-Estt.(D) dated 19.05.2009 of the Govt of India, Ministry of Personnel, Public Grievances & Pensions (Department of Personnel and Training) and endorsed by Finance (Budget) Department, Govt. of NCT of Delhi vide No. 11(4)/2006-Fin(B)/Pt-II/dsfb/1192/1297 dated 27.05.2009, the Principal Secretary(Plg) is pleased to nominate the following **Statistical Assistant** on completion of 20 years of regular service for grant of Financial Up-gradation from the corresponding Pay Band-2 of Rs. 9300-34800/- Grade Pay- 4200/- to the immediate next higher Grade Pay of Rs. 4600/- in the hierarchy of the recommended revised Pay band w.e.f. the dates mentioned against their names:-

The official concerned may be allowed to exercise their options if any under FR22 within one month of the issuance of the order granting the financial up-gradation under the Modified Assured Career Progression Scheme to their Administrative Department directly.



However, the grant of higher Pay Scale is subjected to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.

The Head of the Department concerned is requested to ensure before issuing the final order that 20 years regular service of the officials does not include the period of service rendered in State Government/Statutory body/Autonomous body/Public Sector Organisations, the period of past service in these bodies is not counted for grant of financial up-gradation under the Modified Assured Career Progression Scheme.(Point no. 10 of DoPT OM dated 19.09.2005).

The concerned Head of the Department are requested to issue formal order for grant of financial up-gradation in respect of the above mentioned Officers/Officials working in their Department. However, before the issuance of the formal order the Heads of the Departments may again confirmed that these officials have completed 20 years regular service since the date of their initial appointment and are clear from vigilance angle.
