**ORDER NO. 16 /2020**

The Hon' Lt. Governor, Delhi has accorded ex-post facto approval/approval for extension of Ad-hoc promotion period of the following Statistical Officers, Group 'B', Gazetted in the Pay Scale of Level-7 of pay matrix Rs. 44,900 – 1,42,400 to the post of Asstt. Director (Plg./Stat), Group 'A', Gazetted in the Pay Scale of Level-10 of Pay matrix Rs. 56,100 – 1,77,500 as per 7<sup>th</sup> CPC in the Govt. of NCT of Delhi for two subsequent periods of six months each, or till the post is filled up on regular basis whichever is earlier, as per the details given below:-

2. The aforesaid extension of Ad-hoc promotion to the post of Assistant Director (Plg./Stat.) is subject to the following conditions:
  - i) The Ad-hoc promotion to the post of Assistant Director (Plg./Stat.) shall not bestow on the officers any claim to regular promotion to the grade.
  - ii) The service rendered on ad-hoc basis in the grade of Assistant Director (Plg./Stat.) would not count for the purpose of seniority in that grade or for promotion to the next higher grade.
  - iii) The Ad-hoc promotion shall not confer any right on the incumbents to continue in the grade indefinitely and may be terminated at any point of time without giving any reasons thereof.
  - iv) This extension of Ad-hoc promotion is only for a period of six months or till further orders, whichever is earlier. The Government reserves the right to cancel at any time the ad-hoc promotion and revert the government servant to the post from which he/she was promoted.
  - v) The Ad-hoc promotion is subject to the final outcome of Original Application No. 4554/2015 filed by Shri Ashutosh Kumar & Ors vs Govt. of NCT of Delhi.
