**ORDER**

Whereas, the Department of Pension and Pensioners Welfare's OM No.57/05/2021-P&PW (B) dated 03.03.2023 has been endorsed by Finance (Policy) Department, GNCTD vide No.F.20/07/2022/Finance (Policy)/ 951-959 dated 12.04.2023 and further Circulated by Cadre Controlling Unit (CCU), Planning Department, vide No. F.9 (54)/2023/CC/Plg/5973-6077 dated 11.05.2023.

And whereas, OM No. 57/05/2021-P&PW (B) dated 3rd March, 2023, prescribes in Para 4, reproduced as under:

*"The matter has been examined in consultation with the Department of Financial Services, Department of Personnel & Training, Department of Expenditure and Department of Legal Affairs in the light of the various representations/references and decisions of the Courts in this regard. In this regard, it has now been decided that, in all cases where the Central Government Civil employee has been appointed against a post or vacancy which was advertised/notified for recruitment/appointment, prior to the date of notification for National Pension System i.e. 22/12/2003 and is covered under the National Pension System on joining service on or after 01/01/2004, may be given a one-time option to be covered under the CCS (Pension) Rules, 1972 (now 2021). This option may be exercised by the concerned Government servants latest by 31/08/2023."*

And whereas, OM No. 57/05/2021-P&PW (B) dated 3rd March, 2023, issued by the office of Additional Secretary to Government of India, prescribes in Para 9, reproduced as under:

*"All Ministries/Departments are requested to give wide publicity to these orders without fail. The cases of those Government servants who fulfill the conditions mentioned in this O.M. and who exercise option to switch over to the pension scheme under CCS (Pension) Rules, 1972 (now 2021) may be settled by the administrative Ministries/Departments in accordance with these orders."*

And whereas, a close perusal of the OM No. 57/05/2021-P&PW (B) dated 3rd March, 2023 reveals that it mandates the following two eligibility conditions for conversion from the National Pension Scheme to the Old Pension Scheme:

1) The Govt. Employee should have been appointed against a post or vacancy which was advertised/notified for recruitment/appointment, prior to the date of notification for National Pension System i.e. 22/12/2003.

II) The Govt. Employee is covered under the National Pension System on joining service on or after 01/01/2004.

has been examined in terms of Department of Pension and Pensioners' Welfare's office Memorandum No. 57/05/2021-P & PW (B) dated 03.03.2023 and it is revealed that they have been appointed against the Post Code 019/2002, advertised vide Advertisement No 01/2002 dated 13/05/2002 in the year 2002 by DSSSB for recruitment to the post of Statistical Investigator. The exam for the post was held on 02/03/2003.

Now therefore, in view of the above stated factual positions, above mentioned Statistical Officer/ Statistical Assistant meets the guidelines issued by the Department of Pension and Pensioners Welfare's vide O.M. No. 57/05/2021-P&PW(B) dated 03.03.2023 which was endorsed by Finance (Policy) Department, GNCTD vide No.F.20/07/2022/Finance(Policy)/951-959 dated 12.04.2023 and Circulated by CCU, Planning Department, GNCTD vide No. F.9 (54)/2023/CC/Plg/5793-6077 dated 11.05.2023.

Accordingly, Chief Secretary, Delhi/Appointing Authority of Statistical Officer/ Statistical Assistant has accorded his approval for switch over in r/o above mentioned Statistical Officer/ Statistical Assistant to the Old Pension Scheme under CCS (Pension) Rules, 1972 (now 2021) from National Pension System (NPS).

This order is being issued in compliance of the directions of the Department of Pension and Pensioners Welfare's vide Office Memorandum No.57/05/2021-P &PW(B) dated 03.03.2023 duly endorsed by Finance (Policy) Department, GNCTD vide No.F.20/07/2022/Finance(Policy)/951-959 dated 12.04.2023.



Accordingly, respective Administrative Departments are hereby requested to take further necessary action in reference to the para 8 of the OM dated 03.03.2023.
