

WOMEN AND CHILD DEVELOPMENT

1. Department of Women & Child Development has made concerted efforts to provide welfare services and development programmes to a wide range of beneficiaries i.e. women in distress, institutional and non-institutional services/programmes for the care, treatment, rehabilitation and protection of the children, and further initiating steps for the economic empowerment of women.

With the expansion and focus on matters concerning the development of women and children, the Government of National Capital Territory of Delhi in November 2007 decided to have a separate Department for Women and Child Development.

2. 11TH FIVE YEAR PLAN ACHIEVEMENTS

During the 11th Five Year Plan 2007-12 the WCD dept. is entrusted with implementing programme and schemes for empowerment of women and providing social security to them. The department is also entrusted to implement the scheme and programme for child development.

Women Empowerment

- One time financial assistance to widows for performing marriage of their daughters enhanced from Rs. 20,000/- to Rs. 25,000/- . In the current financial year 2500 women beneficiaries would benefit under the scheme.
- Pension to women in distress is being given to 78000 women beneficiaries through ECS.
- 104 Gender Resource Centers and 24 Extension Gender Resource Centers setup in Delhi.
- 15 Aawaz Uthao Collectives setup in Delhi in backward areas with objective to support women in distress.
- Rajiv Gandhi Scheme for empowerment of Adolescent Girls (SABLA) launched on pilot basis in 3 districts. 1.67 Lakh Adolescent Girls benefiting under the scheme.
- Indira Gandhi Matritva Sahyog Yojna (IGMSY) introduced on pilot basis in 2 districts. 1365 No of eligible pregnant and lactating women were identified and cash transfer made to 340 women, which is the first in the country.
- Mental Health Unit established at Nirmal Chaya Complex for providing counseling services.
- 2 Shelter Homes in collaboration with YWCA setup for destitute pregnant and lactating women at Jahangirpuri and Sarai Rohilla. These Homes are super-specialty homes and one of its own kind.

- Under 'Protection of Women against Domestic Violence Act, 1981 domestic Incident reports were prepared and 95 cases disposed of.
- 2 Working Women hostels constructed at Dwarka and Rohini and soon will be made operational.
- Special fast track courts set up for the trial of rape victims on the initiative of the Department.
- Special coach for women introduced in metro trains.
- Grant-in-aid to YWCA has been released to Working Women Hostel at Vishwas Nagar.

CHILD WELFARE

- Under LADLI Scheme, 19154 cases were sanctioned in the year 2010-2011.
- 3 HUB Centers established in ICDS Projects Kondli, Okhla & Meethapur to provide and demonstrate Quality Services for children, pregnant and lactating mothers.
- Setting up of De- addiction center at observation home for boys- II, Sewa Kutir Complex, Kingsway Camp.
- Launching of “Found Children Website ” to facilitate people to access information of a missing child. The Website address is <http://cwc.wcdde.in>.
- 6 Child Welfare Committees at Lajpat Nagar, Mayur Vihar, Alipur, Kingsway Camp, Nirmal Chhaya, Shankar Market and Connaught Place, New Delhi constituted for the children in need of care and protection.
- 3 Juvenile Justice Boards constituted at Ferozshah Kotla and Kingsway camp for juvenile in conflict with law.
- 14th November celebrated as “Children’s Day” in the lawns of the residence of Hon’ble Chief Minister.
- Diwali mela organized for all residents of Homes in Nirmal Chaya Complex.
- Collaboration with many NGO’s in the form of Non Formal Education (Subhakshika). Vocational Education (Subhakshika and Sun Foundation), Mental Health (Manas), restoration (Sathi) etc.
- Special courts for trial of offences against children set up in Delhi amongst the first in the country.

3. The approach paper for 12th Five Year Plan recommends to create safe, supportive and responsive environment for Women and Children with the convergence of various programme to improve educational, security, lively hood, working and living environment to all the deprived section of the society.

- Delhi Govt. has decided to give higher rate of Rs. 1500/- per month as “Pension to Women in Distress” to SC/ST Women in Delhi so as to provide them more dignified life.
- Skill development is one of the major programmes to be taken up during 12th Five year Plan under Delhi Skill Development Mission. A world class skill development centre is being set up in collaboration with ITE, Singapore
- Separate Juvenile Homes will be set up for the children below 10 years of age and separate for children above the 10 years of age so that the children below 10 years of age may not face the rough and tough behavior of the senior age group inmates.
- Women and Child Development Department is planning to set up Anganwari Hubs for about 10 Anganwari centers in each area as at present availability of suitable accommodation for AWC's at a present rate of Rs. 750/- P.M. is very difficult task.
- The empowerment of women will continue as one of the major programme during the 12th FYP. More than 120 Gender Resource Centre (GRC's) of Samajik Suvidha Sangam (SSS), 94 ICDS projects, Delhi Commission for Women, WCD Dept., a no. of NGO's and Civil Society organization as well as other agencies like Delhi state Health Mission, Sarv Shiksha Abhiyan of Dte. Of education etc. will continue to implement the programmes for successful empowerment of women in Delhi. The ladli Yojna, Free supply of sanitary napkins to girls students, Technical university for women, Matri Shishu Suraksha Yojna are some of the programmes being implemented by various departments which will make best contribution for welfare and empowerment of Women.

SOCIAL SECURITY FOR WOMEN

5.1 Delhi State Commission For Women:

Plan Outlay

12th Five Year Plan 2012-17: Rs.2000.00 Lakh

Annual Plan 2012-13: Rs.327.00 Lakh

Women & Child Development Department is the administrative Department for Delhi commission for Women (DCW) which takes up cases of violation of safe- guards provided for women under the Constitution and other laws.

Under the Sahyogini Programme more than 2000 cases of matrimonial disputes, divorce, child custody, maintenance, sexual harassment at work place etc. were received. In this programme a panel of Members and legal advisors hold counseling sessions for the disputed parties till a solution is reached. Through this programme the Commission has created a friendly space where sensitive family issues can be discussed and reconciliation achieved at the pre-litigation stage.

The pre-marital counseling cell provides counseling services to the about to marry/ newly married couples and their families.

Forty four Mahila Panchayats managed by twenty two have been formed all over Delhi to resolve miscellaneous disputes affecting women.

5.2 Strengthening of Children And Women Institutions:

The Department of Women and Child Development are maintaining and running 46 Institutions for providing care, protection and rehabilitation of the juveniles and women. Through this programme, the concept of creating social security to the target groups gets translated into reality. The WCD proposes to modernize the Institutions / homes by automation, eco-friendly technology such as solar lighting, solar heater etc. and training on modern management & orientation.

5.3 Working Women Hostels :

Plan Outlay

The aim of the scheme is to provide a dignified proper and affordable shelter to women who are employed and do not have any living accommodation in the city. The present number of Working Women's Hostel is full and not in a position to accommodate the large number of Women who are waiting for such residential admission. Hence, there is an increasing need for constructing more Working Women Hostels. Presently there are 19 Working Women Hostels run by Govt./Voluntary Organizations. Possession of land at Dheerpur, Basant Village, and Tughlakabad has been taken over from DDA. The Working Women Hostel at Vishwas Nagar which was constructed sometime ago has been handed over to the YWCA for its day to day running and operationalisation.

The Delhi Govt. has recently completed the construction of two buildings for setting up Working Women's Hostels at SPS sector, 22, Rohini and PSP Pocket, Sect. 8, Dwarka. The Deptt. has issued a notice in the newspapers thereby inviting proposals from organizations having the required experience, to run working women hostels in these buildings on no-profit no-loss basis. After screening the applications, the appropriate organizations would be selected to run the working women hostels.

5.4 Pension to Women in Distress:

Plan Outlay

The Department is implementing scheme of pension to women in distress like abandoned, separated, divorced and destitute women. The rate of pension is Rs. 1000/- per month, which is remitted quarterly in their bank account. Those women are eligible who are having annual income of less than Rs. 60,000/- and are residents of Delhi for last five years. The criteria would broadly follow the benefits available to persons getting old age pension as per cabinet decision No. 1605 dated 22-12-2009. It is proposed that under this scheme an additional amount of Rs. 500/- p.m is to be given to SC/ST/Min. beneficiaries.

Aims and objective:-

To provide social security by way of financial assistance to widows, divorced, separated abandoned deserted or destitute women in the age group of 18 to 60 years who have no adequate means of subsistence and are poor, needy and vulnerable.

Eligibility:

A women in distress as defined in clause (G) of rule 3 shall be eligible for financial assistance under this scheme if: -

- i) She has been identified as an entitlement holder by SSS
- ii) She has been residing in Delhi for more than 5 years preceding the date of application
- iii) She has a 'singly operated ' account in any bank for receiving the payment through electronic clearing system
- iv) She is not receiving any pension from Central Govt./State Govt./ MCD and NDMC or any other source for this purpose
- v) She is not receiving any maintenance allowance from spouse by any judicial order

Verification and Sanction of assistance:

The District Social Welfare Officer/ Women & Child Development Officer/Joint Director (FAS) shall be the competent authority for verification and sanction of the payment under the scheme.

Discontinuation of Assistance

- i) The sanctioning authority shall have the right to stop payment of assistance if at any stage it is found that it was sanctioned on furnishing of fake documents or the conditions for which the assistance was granted no longer exist.
- ii) If it is found that the assistance was sanctioned on furnishing of false documents, penal action shall be initiated and appropriate liability fixed against people furnishing false documents.
- iii) If person resorts to professional begging i.e. if the person has been apprehended and warned or any other proceedings conducted by the court in regard against him/her the assistance shall be forfeited.
- iv) The assistance shall cease to be payable on the death of the beneficiary and if the person dies before receiving assistance for a particular period, the same shall lapse.
- v) The pension shall be stopped if: -
 - a. A widow or divorcee remarries
 - b. The separated/ deserted woman reconciles with her husband/ partner or remarries

5.5 Crisis Intervention Centers For Girls/Women:

The aim of the scheme is to provide protection and respite to women in distress within their reach through short temporary shelter. The strengthening of complex Nirmal Chhaya, a protective home in Delhi run by Department of Women & Child development is under progress along with setting up of a Counseling Centre to provide counseling, referral and rehabilitative services to women, victims of atrocities in the family, society and Training-cum-Production Centre would be a positive step. A piece of land has been taken over at Rohini and building plan have been agreed. The construction work has been started by DSIDC. Such centers have to be established in each district.

5.6 Financial Assistance To Lactating And Nursing Mothers Belonging To Weaker Section of Society:

The objective of the scheme is to provide financial assistance to the mothers of newly born children belonging to weaker section of society for nourishing meals, who cannot afford to have balanced diet after delivery because malnutrition is widely prevalent in poor families. This assistance is meant for providing good nourishment to the lactating mothers throughout the period of lactation. The quantum of assistance will be Rs. 500/- only and will be restricted to the mother for one child only.

5.7 Financial Assistance To Poor Widows For Performing Marriage Of Their Daughters And Orphan Girl:

Plan Outlay**12th Five Year Plan 2012-17:** Rs.4000.00 Lakh**Annual Plan 2012-13:** Rs.700.00 Lakh

This scheme has been transferred from the Department for the Welfare of SC/ST/OBC/Min. to the Department from financial year 2006-07. The aim of the scheme is to provide financial assistance of Rs. 25,000/- to the poor widows for performing marriage of their daughters so as to enable them to meet expenses involved in solemnizing marriage of their daughters also to orphan girls for their marriage. It is proposed that the widows of SC/ST/Min. community to be given Rs. 5000/- one time assistance as an additional amount. The family income ceiling is enhanced from existing Rs. 48000/- to Rs. 60000/- per annum w.e.f. April 2009. This assistance is paid up to two daughters only. The applicant should be permanent residents of Delhi for the last five years. Annual family income of less than Rupees sixty thousand. The following documents are required: -

1. Ration card or election card
2. Birth certificate of the girl
3. Self declaration of income
4. Death certificate
5. Marriage Card

5.8 Bhagidari: New Initiatives In Social Development:**Plan Outlay****12th Five Year Plan 2012-17:** Rs.9800.00 Lakh**Annual Plan 2012-13:** Rs.1850.00 Lakh

The objective of the scheme is to improve the services through effective management with participation and collaboration with other departments and NGOs, RWAs etc. and to provide package of services in the area of empowerment of women, care of elderly etc. Some of the programmes proposed under Bhagidari are as follows:

GENDER RESOURCE CENTRE PROJECT (GRC)

Gender Resource Centre is a programme run for women Empowerment and a sequel to Stree Shakti Programme, shifting from the camp based approach to permanent set ups in the neighborhood, of the community. The GRCs, are envisaged as instruments to

bring about health, socio-economic, literacy & legal empowerment of women particularly those belonging to the under privileged sections of the society. Presently, there are 104 GRC-Suvidha Kendras and 20 extension centers covering 9 districts of Delhi. The Department of Women & Child Development sanctions Grant-in-Aid to support NGOs to run need based Skill Development trainings and awareness programmes on health, nutrition and legal issues. Under Bhagidari Scheme, in the last financial year, more than 1.58 lac women have benefited through the Health clinics, approximately 1.88 lac people through the Health Camps and more than 82,000 persons have benefited through the nutrition camps. About 16,700 women have benefited through different skill development courses in trades of beauty culture, cutting and tailoring, dress making, photography and videography, computer, home mangement and catering, embroidery and jute bag making whereas, around 60,000 women were provided free legal aid and counseling.

SAMAJIK SUVIDHA SANGAM/ MISSION CONVERGENCE

The project GRC, is under the administrative control of SSS/ Mission Convergence, Samajik Suvidha Sangam/ Mission Convergence was recently awarded the CAPAM (Commonwealth Associations for Public administration & Management) Innovations Award for Innovation in 2010 out of 150 nominations this year. The Award is an affirmation of Delhi Governments commitment to the poorest of the state poor. It has recognized and applauded Mission Convergence's efforts in breaking the barriers between the government and the most marginalized sections of the poor, thus becoming a bridge bringing the government to the doorsteps of the poorest households Not only are the voices of the poor being heard now but also their needs fulfilled and grievances redressed through the single window platform of the Mission.

Approximately 50 lakh poor persons have been identified by the Mission through its unique survey based on vulnerability criteria. The network of 124 GRC-SKs is reaching out to this huge population that had for one reason or other been denied the fruits of development. Special emphasis is being laid on holistic empowerment of women under its various programmes like Literacy, Skill Development, Livelihood, Legal Awareness, Health & Nutrition etc.

About 5.65 lakh women were benefited through these activities between 2008 and March 2010.

A special programme to sensitize and provide easy and affordable access to menstrual health and hygiene of women was launched in September 2010 by the Mission under which affordable branded sanitary napkins are being provided to the poor adolescent girls and women through the network of GRC centers.

Information and awareness on various welfare schemes was provided to more than one lakh people and over 16000 persons benefitted through the grievance cell of the Centres.

Mission Convergence has played a pivotal role in institutionalizing a mechanism for comprehensive assistance and care of the Homeless in Delhi, estimated to be around a lakh. On July 2, 2010 the Govt of Delhi launched the Homeless survey under which

approximately 62,000 homeless have been mapped. The Government of Delhi gave out the first 100 Beghar Cards to the homeless residing in Nizammuddin area on October 2, 2010 at the launch of Adhaar (UID numbers) in New Delhi. The UIDAI provided the first 40 provisional Adhaar Cards in Delhi to the homeless mapped by Mission on the occasion.

Two central schemes, namely, SJSRY and RSBY, have taken giant steps in the state since the Mission became their implementing agency. Over 2 lakh persons have been enrolled under the RSBY scheme through the GRC centers while approximately 35 lakh persons have been covered for benefit under the SJSRY.

A BRIEF NOTE OF THE PROJECT FOR THE 'HOMELESS'

As per the order of the Hon'ble High Court, the project for the 'HOMELESS' is being implemented by 'Samajik Suvidha Sangam'/ Mission Convergence, GNCT of Delhi. The Department of Women and Child Development released the funds to 'Samajik Suvidha Sangam' as Grant -in- aid in the Financial Year 2009-10. A long- term comprehensive plan for providing shelter and other facilities to the "Homeless" is being worked out by the mother NGO and 6 Resource Centers identified under the project by "Samajik Suvidha Sangam'/ Mission Convergence. The Expenditure was debitable to the Major Head 2235 B-2(1)(5)(1) Bhagidari: New Initiatives in Social Development on in the F.Y. 2009-10 Under the demand No. 8 (PLAN) which had a budget provision of Rs. 18.65 Cr. In the Financial Year 2009-10 an amount of Rs. 1,29,52,000/- has been released as GIA by the Department of Women and Child Development to 'Samajik Suvidha Sangam' for the "HOMELESS" Project in the F.Y. 2009-10

5.9 Honorarium To Anganwari Workers And Helpers:

Annual Plan 2012-13: Rs.2600.00 Lakh

The aim of the scheme is to pay honorarium to 11090 Anganwari workers and 11090 helpers for the work and the records they prepare in an Anganwari particularly pertaining to nutrition programme and nutrition health education.

The State share of the honorarium to Anganwari workers has been enhanced from existing Rs.500/- to Rs 1000 p.m. and for Helpers from Rs.200/- p.m. to Rs 500 p.m. w.e.f. April 2008. The State Govt. is also paying 10% cost of Govt. of India share of honorarium i.e. Rs. 300/- to Anganwari worker and Rs. 150/- to helper. The State Govt. has also decided to supplement the amount of the best Anganwadi Worker award. The details of honorarium to AWW and AWH with sharing ratio between Central Govt. and State Govt. from April 2011 are as follows:

The aim of the scheme is to pay honorarium to Anganwari workers & helpers for the work & the records they prepare in an Anganwari which is run by NGO's particularly pertaining to nutrition programme and nutrition health education. The State Government has given honorarium to Anganwari workers and helpers Rs.1000/- p.m. & Rs.500/- p.m. w.e.f. Annual Plan 2009-10. The State Govt. is also paying 10% cost of Govt. of India share of honorarium i.e. Rs. 300/- to Anganwadi worker and Rs. 150/- to helper.

5.11 Implementation of Protection Of Women From Domestic Violence Act 2005

The Protection of Women from Domestic Violence Act 2005 has come into force from 26.10.2006. The Act is aimed at providing protection to wife or female live-in partner from violence at the hands of the husband or male live-in partner or his relatives. The Law extends protection to women who are sisters including adopted sisters and mothers. Domestic violence under the Act includes actual abuse or threat of abuse, whether physical, sexual, verbal, emotional, or economic. Harassment by way of unlawful dowry demands to the women victim or her relatives would also be covered under the definition of Domestic violence. The Deptt. of Women & Child Development, Government of Delhi is the Nodal Department for the implementation of provisions under the Act. For effective implementation, the Rules provide for

- Appointment of Protection Officers in each district as per section 8 of the Act and provide them with necessary infrastructure to enable them to start functioning
- Invite applications from service providers as per Rule 11 and register them after due verification as regards their suitability
- Publish the names and addresses with telephone number of the Protection Officers and the service providers.
- Wide publicity to the provisions of the Act.

The Department of Women and Child Development has presently appointed 17 Protection Officers on contract basis who are attached with the various Mahila Courts. The Protection Officers shall be under the control and supervision of the Magistrates and perform the duties given by the Magistrates {as per Section 9(2)}.

The implementation of the Act provides for effective coordination and correspondence between Protection Officers, Police service providers, aggrieved persons and their

family/relatives. Upto Dec.2010, 8662 complaints of Domestic Violence have been received in various Mahila Courts in Delhi.

Provides Grant-in-aid to the State Child Protection Society as State Component for its activities such as running of Shelter Homes, open shelter, innovative programme, Awareness Activities, IEC etc. To develop infrastructure, State Child Protection Unit, District Child Protection Units, State Adoption Resources Agency Salary, Maintenance of Homes, Consultancy, GIA to NGOs ,Rent, etc.

The society was formed in 2010 under the Centrally Sponsored Scheme. Integrated Child Protection Scheme(ICPS). The Scheme will continue to incorporate more programme and develop infrastructure to achieve the objectives of ICPS. Constitution of State Child Protection Society, State Adoption Resources Agency. GIA to 6 NGO run Shelter Homes,11 Open Shelter for children,

5.17 Foster Care Home Services :

The concept of Foster Care Services involves a substitute family for a temporary period till the child's own family is in a position to accept them in the family. This will help in the restoration of children & would provide children suitable families. The NGO's will also do counseling of the families & supervise the child once placed.

5.18 Implementation Of Juvenile Justice (Care And Protection Of Children):

The Juvenile Justice Act 2000 received the assent of the President of India on 30th December 2000. The Act provides for the care, protection, treatment, development and rehabilitation of neglected and delinquent children and also spells out the machinery and infrastructure required for this. The JJ Act 1986 has been replaced. Some of the provisions of the JJ Act 2000 have been amended through the Juvenile Justice (Care and Protection Of Children) Amendment Act 2006, which received the assent of the President of India on 22nd August 2006.

The department has already taken the Initiatives for Implementing the Juvenile Justice (Care and Protection of Children) Amendment Act 2006.

Under the Act it is incumbent upon the deptt. to set up Juvenile Justice Boards, Child Welfare Committees, Children Homes, Observation homes, Special Home and place of safety. Three Juvenile Justice Boards and four Child Welfare Committees are functioning . The Department of WCD is running 21 children homes, 4 observation homes, 1 place of safety, one special home to provide a child friendly environment and also ensure rehabilitation of children in conflict with law and those requiring protection and care by providing vocational training and restoration to the family. Accordingly it is proposed to start training in vocational like Electronic Trade (TV repairing), Electric Trade (House Wiring etc.), Mechanical Trade (Auto Repair etc.), Stenography, Typing / Computer, cutting and tailoring, phone repairing ,DTP, candle making and plumbing etc.

CHILD WELFARE COMMITTEES (CWCs)

Under the Juvenile Justice (Care & Protection of Children) Act, 2000, in order to ensure speedy and timely decisions on matter pertaining to care, protection and rehabilitation of children in need of care & protection and Juvenile in conflict with Law has constituted six Child Welfare Committees and three Juvenile Justice Boards. Creation and Maintenance of 6 Child Welfare Committees, Awareness Programmes, Maintenance of Found Children Website, Restoration of Children etc.

WELFARE OF CHILDREN/JUVENILES

The Department of women & Child Development has set up 27 children Institutions under the various provisions of Juvenile Justice (Care & Protection of Children) Act, 2000 to cater to the Children in need of Care & Protection and also to the juveniles in conflict with law. These Institutions include [i] Three Observation Home for Boys; [ii] One Observation Home for Girls; [iii] One Place of Safety, and [iv] One Special Home for Boys and 21 Child Care Institutions. It is proposed to setup a separate juveniles home for children up to the age of 10 years.

The Department is encouraging NGO participation and has recognized NGOs who run Children Homes and Shelter Homes u/s 34 and 37 of the Juvenile Justice (Care and Protection of Children) Act, 2000. At present there are 54 NGOs running child care institutions.

5.19 Delhi Commission for Protection of Child Rights (DCPCR):

Constitution of Delhi Commission for Protection of Child Rights(DCPCR). This Commission is empowered to undertake enquiry into complaints and to take suo-moto notice of matters relating to:-1) deprivation and violation of child rights ii)Non-implementation of laws providing for protection and development of children iii)Non-compliance of policy decisions, guidelines or instructions aimed at mitigating hardships to ensuring welfare of the children and to provide relief to such children or to take up the issues arising out of such matters with the appropriate authorities. Constitution of DCPCR, maintenance of building/office, salary of Chairperson, Members and supporting

staff , consultancy, office equipment, projects Transportation etc. The DCPCR shall conduct seminars, projects, workshops etc as per requirement from time to time. DCPCR shall keep liasoning with Department of WCD, labour Department, Education Department M/O Labour in relation matter related to child issues.

5.20 Laadli:

Plan Outlay

12th Five Year Plan 2012-17: Rs.60000.00 Lakh

Annual Plan 2012-13: Rs.10000.00 Lakh

It is a new scheme introduced w.e.f. 01.01.08. Its main objective are to promote socio-economic development of the girl child by providing education-linked financial assistance. Eligibility conditions are that the girls child should be born in Delhi. Her parents must be resident of Delhi for at least 3 years prior of filling the application and the annual family income should not exceed Rs.1.00 lac per annum. The amount of financial assistance at different stages is as under :- Under this scheme Rs. 11000/- are deposited in the name of the girl child if she is born in a hospital/Nursing Home in NCT of Delhi on or after 1/1//2008 and Rs. 10000/- are deposited in the name of the girl child if she is born on or after 1/1/2008 other than the hospital. Rs. 5000/- is also deposited in the name of the girl child on admission in classes 1, VI, IX, and passing X and on admission in Class XII. The maturity amount can be claimed when the girl child attains 18 years of age and passes class-X as a regular student or takes admission in class-XII. Approximately 5,00,000 girls have so far being registered in the scheme of which 70,000 girls have received their final maturity value.

The aim of this scheme is to provide awareness regarding available services for the welfare of deprived and disabled through workshops, meetings on social issues, and to generate positive public opinion towards various issues concerning protection of girl child, handicapped and women etc. and to sensitize the society regarding the existing social problems. The Department proposed to get some video spots / short documentaries on the right of child with particular emphasis on the girl child and women.

Awareness Campaign for Bhagidari initiatives and workshops would be arranged and would be linked to programme of Asian Network for Metro cities. Provision for undertaking studies on various issues is also included under the scheme.

5.23 State Programme Of Events For Socially & Physically Disadvantaged Persons:

The aim and objective of the scheme is to make the Socially & Physically disadvantaged groups to be a part of the community and display their skills and expertise in their respective crafts or traditional occupational vocations. Under the scheme, exhibitions will be held displaying the goods prepared by them in the stalls. This programmes will create massive awareness in the community regarding the need and capabilities of the disadvantaged groups. The Voluntary organization are assisted for their specific project for holding of the events on State and National/ International Level. Funds required to be disbursed to NGO's for care giving training, education and vocational training programme as earmarked will be utilized.

5.24 Security – Internal And External And Augmentation Of Sanitation:

homes. From 10th Five Year Plan, Security (external and internal) and sanitation work had been outsourced. Under the scheme, payment is made to the private agencies for security and sanitation services in the homes/institutions being run by the Deptt. of Women & Child Development.
