IIP UNIT(INDEX OF INDUSTRIAL PRODUCTION) (IInd Quarter July 2018- September 2018)

(Base Year: 2011-12=100)

- **1.1** Directorate of Economics & Statistics, Govt. of NCT of Delhi compiles the Index of Industrial Production (IIP) for Delhi on monthly basis and releases on annual/quarterly basis. The base year for the IIP is 2011-12=100. IIP is the short term indicator of the trend in organized manufacturing sector. For IInd quarter of CFY 2018-19, the IIP is compiled on the basis of monthly production data received from 137 industries comprising 136 manufacturing units and an electricity production unit. For the purpose of compiling IIP, the industry sector has been divided into manufacturing and electricity sector. 58.61% weight has been assigned to manufacturing sector whereas electricity sector has been assigned 41.39% weight. The manufacturing sector has been further divided into 23 major industrial groups at two digit level NIC-2008.
- **1.2**The comparison of the IIP of Delhi for the II^{nd} quarter of current financial year (CFY) 2018-19 has been made with the I^{st} quarter of CFY 2018-19.



1.3 The salient features of IIP for IInd Quarter (July 2018-September 2018) of C.F.Y. 2018-19.

- ➤ 6.82% Growth has been recorded in Manufacturing sector of IInd quarter 2018-19 (July to September 2018) as compared to the 1st quarter of C.F.Y 2018-19 (April to June 2018).
- ➤ Electricity sector in Delhi has been recorded negative growth of 15.89% during the quarter. The reason for this negative growth may be the result of decreased electricity production in gas based IPGCL-PPCL power stations.
- > Overall 3.64% negative growth has been recorded in General Index during the quarter.

1.4 Index of Industrial Production at the level of NIC two digit


- Out of 23 major groups (NIC-2digit), 10 groups have shown growth in Industrial Production during IInd quarter of 2018-19 as compared to Ist quarter of 2018-19.
 - The four major NIC Groups at NIC two-digit level which have the major impact for positive growth in overall IIP during IInd quarter of 2018-19 are as follows:
- Manufacturing of food products (NIC-10) with weight of 143.18 in IIndQtr of 2018-19 has shown a growth of 17.63% in IIP as compared to IstQtr of 2018-19.
- Manufacturing of motor vehicles, trailers etc (NIC-29) with weight of 45.79 has registered a growth of 9.87% in the IIP of IIndQtr of 2018-19 as compared to IstQtr of 2018-19.
- ➤ Manufacturing of chemicals and chemical products (NIC-20) with weight of 24.62 has registered a growth of 15.62% in the IIP of IIndQtr of 2018-19 as compared to IstQtr of 2018-19.
- ➤ Whereas, Manufacturing of rubber and plastics products (NIC-22) with weight of 13.18 has registered a growth of 34.09% in the IIP of IIndQtr of 2018-19 as compared to IstQtr of 2018-19.
- ➤ On the other hand, four major groups namely mfg of leather and related products(NIC-15) with weight of 23.25, mfg of printing and reproduction of recorded media (NIC-18) with weight of 34.93, mfg of machinery and equipment (NIC-28) with weight of 26.92 and mfg of computer, electronic and optical products (NIC-26) with weight of 29.87 which have recorded negative growth by 30.57%, 19.79%, 17.37% and 7.36% respectively during the IIndQtr of 2018-19 as compared to IstQtr of 2018-19.

1.5 Index of Industrial Production with the time-bound Classification

Index of Industrial Production with the Use-Based classification is depicted in Table 4. It is evident that in the IInd quarter of CFY 2018-19, only twogroups, namely, Capital goods and Consumer Non-Durable Goods have exhibited a considerable growth in production index by 3.81% and 14.93% respectively from the ISt quarter of current financial year, i.e. 2018-19. On the other hand, Primary Goods, Intermediary and Consumer Durable Goods are showing decrease in production index by 15.38%, 28.59% and 0.75% respectively in the IInd quarter of CFY 2018-19.
