INDEX OF INDUSTRIAL PRODUCTION

(3rd Quarter Oct. 2018- December 2018)

(Base Year: 2011-12=100)

- **1.1** Directorate of Economics & Statistics, Govt. of NCT of Delhi compiles the Index of Industrial Production (IIP) for Delhi on monthly basis and releases on annual/quarterly basis. The base year for the IIP is 2011-12=100. IIP is the short term indicator of the trend in organized manufacturing sector. For 3rd quarter of FY 2018-19, the IIP is compiled on the basis of monthly production data received from 137 industries comprising of 136 manufacturing units and an electricity production unit. For the purpose of compiling IIP, the industry sector has been divided into **Manufacturing** and **Electricity Sector**. 58.61% weight has been assigned to Manufacturing Sector, whereas, Electricity Sector has been assigned 41.39% weight. The Manufacturing Sector has been further divided into 23 major industrial groups at two digit level of NIC-2008.
- **1.2** The comparison of the IIP of Delhi for the 3rd quarter of financial year 2018-19 has been made with the 2nd quarter of 2018-19.



1.3 The salient features of 3rd Quarter IIP, F.Y. 2018-19

- ➤ 5.20% Growth has been recorded in Manufacturing sector in the 3rd quarter 2018-19 (Oct. to December 2018) as compared to the 2nd quarter of F.Y 2018-19 (July to Sept. 2018).
- ➤ Electricity sector in Delhi has recorded a growth of 7.59% during the quarter.
- ➤ Overall 6.16% growth has been recorded in General Index during the quarter.
- ➤ All India IIP of 3rd Quarter 2018-19 exhibits that there was a growth of 1.77% in Manufacturing Sector, decline of 5.81% in IIP of Electricity Sector and increase of 2.75% in overall General Index as compared to 2nd quarter 2018-19. All India IIP includes Mining Sector also.

1.4 Index of Industrial Production at the level of NIC two digit


- 1. Out of 23 major groups (NIC-2digit), 15 groups have shown growth in Industrial Production during 3rd quarter of 2018-19 as compared to 2nd quarter of 2018-19.
- 2. The five major NIC Groups at NIC two-digit level which have the major impact for positive growth in overall IIP during 3rd quarter of 2018-19 are as follows:
 - a) Manufacturing of food products (NIC-10) with weight of 143.18 in 3rd Qtr of 2018-19 has shown a growth of 15.08% in IIP as compared to 2ndQtr of 2018-19.
 - b) Manufacture of machinery and equipment n.e.c. (NIC-28) with weight of 26.92 has registered a growth of 61.23% in IIP in 3rd Qtr of 2018-19 as compared to 2nd Quarter.
 - c) Printing and reproduction of recorded media (NIC-18) with weight 34.93 has registered a growth of 40.31% in IIP in 3rd Qtr of 2018-19 as compared to 2nd Quarter.
 - d) Manufacture of motor vehicles, trailers and semi-trailers (NIC-29) with weight of 45.79 has shown a growth of 11.73% in IIP in 3rd Qtr of 2018-19 as compared to 2nd Quarter.
 - e) Manufacture of fabricated metal products, except machinery and equipment (NIC-25) with weight of 26.69 has registered a growth of 13.85% in IIP in 3rd Qtr of 2018-19 as compared to 2nd Quarter.
- 3. On the other hand, three major groups namely manufacture of wearing apparel (NIC-14) weight 102.30, Manufacture of electrical equipment (NIC-27) weight 35.87 and Manufacture of textiles (NIC-13) Weight 13.74 which have recorded negative growth by 20.30%, 11.30% and 15.09% respectively during the 3rd Qtr of 2018-19 as compared to 2nd Qtr of 2018-19.

1.5 Index of Industrial Production as per Use-based Classification

Index of Industrial Production with the Use-Based classification is depicted in Table 4. It is evident that in the 3rd quarter of FY 2018-19, Two groups , namely, Primary goods and Consumer Non-Durable Goods have exhibited a considerable growth in production index by 7.52% and 15.71% respectively from the 2nd quarter of financial year, i.e. 2018-19. At the same time, Index for Intermediary Goods has shown extra ordinary growth of 123.29%. However, this extra ordinary increase in the IIP of Intermediary Goods had a smaller impact on overall IIP as the weight of former is only 2.05% of total. On the other hand, Capital goods and Consumer Durable Goods have shown negative growth in production index by 1.20% and 15.65% respectively in the 3rd quarter of FY 2018-19 as compared to Index of 2nd Quarter 2018-19.
