The promotion shall be subject to outcome of further orders that may be passed by the Hon'ble Supreme Court in the case of *Jarnail Singh & Ors (Civil Appeal No. 629 of 2022) arising out of SLP(C) No. 30621/2011* as conveyed by the DoPT vide O.M. No. 36012/16/2019-Estt. (Res.) dated 12.04.2022. Further, the promotion shall also remain subject to the final outcome of the Original Application No. 4554/2015 filed by Shri Ashutosh Kumar & Ors. vs. Govt. of NCT of Delhi and OA No. 757/2024 filed by Shri Thakur Dayal vs. Govt. of NCT of Delhi in the Principal Bench of CAT, New Delhi.

4. The pay of the above-mentioned officer shall be fixed under FR-27 at the stage it would have reached had she been promoted from the date on which the officer immediately below her was promoted, but no arrears would be admissible as per DoPT's O.M. No. 22011/5/86-Estt.(D) dated 10.04.1989.

5. The concerned head of department (HoD) shall ensure that the promoted officer is clear from the vigilance angle before relieving her to join the post of Assistant Director, as per instructions contained in DoPT OM No. 22011/4/91-Estt.(A) dated 14.09.1992 and other related OMs. If the promoted officer is found to be not clear from the vigilance angle, the same shall be brought to the notice of the Cadre Controlling Unit, Planning Department immediately for further necessary action in the matter.

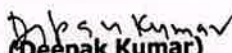
