## Cancellation of Candidature for the post of Statistical Assistant

**ORDER** 

Whereas, Sh. Aakash Harit D.O.B. 12.03.1993 (Roll No.11142200220) has been nominated by DSSSB to Planning Department, GNCTD for appointment to the post of Statistical Assistant (Post Code - 04/17) in Planning & Statistical Cadre, GNCTD vide letter No.F.1(346)/P&P/17/DSSSB/4127-4130 dated 08.10.2020.

And Whereas, Sh. Aakash Harit was called for verification of the correctness of the information/documents as furnished in the application forms and e-dossier vis-à-vis the original documents on 21.10.2020 vide email dated 19.10.2020 on his registered email id (Haritaakash@gmail.com) and he reported on the scheduled date for the same.

And Whereas, on primary scrutiny of the e-dossier and the documents submitted by Sh. Aakash Harit during verification process in Planning Department, it was found that the candidate is unable to produce the necessary documents i.e. Provisional or Original passing certificate in support of his completing the necessary PG Degree Qualification on or before cutoff date for determining eligibility i.e. 21.08.2017 as per advertisement of recruitment dated 18.07.2017 even after a elapse of considerable amount of time and despite several reminders.

And Whereas, the case of Sh. Aakash Harit was placed before the Committee constituted vide Planning Department Order No.24/2021 dated 09.06.2021 for reassessment of the eligibility of such candidates and the Committee recommended that Sh. Aakash Harit (Roll No.11142200220) is unable to produce the necessary documents i.e. Provisional or Original passing certificate in support of his completing the necessary PG Degree Qualification on or before cutoff date for determining eligibility i.e. 21.08.2017 even after a elapse of considerable amount of time and despite several reminders. Therefore, he is ineligible for the post of Statistical Assistant (04/17).

Now, therefore, in view of the above facts, the candidature of Sh. Aakash Harit for the post of Statistical Assistant (Post Code – 04/17) is hereby cancelled and his dossier is returned to DSSSB.
