

Chapter 1: Instructions to Bidders

PREPARATION OF PROPOSAL

i. Proposal Preparation Costs

The bidder shall be responsible for all costs incurred in connection with participation, costs incurred in conduct of informative and other diligence activities, participation in meetings/discussions/presentations, preparation of proposal, in providing any additional information required by PLANNING DEPARTMENT, GNCTD to facilitate the evaluation process or all such activities related to the bid process.

PLANNING DEPARTMENT, GNCTD will in no case be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process.

ii. Language

The Proposal should be filled by the Bidder in English language only. If any supporting documents submitted are in any language other than English, translation of the same in English language is to be duly attested by the Bidders. For purposes of interpretation of the Proposal, the English translation shall govern.

The bids submitted by telex/telegram/fax/e-mail etc. shall not be considered. No correspondence will be entertained on this matter.

CONSORTIUM

Consortium or sub-letting is not allowed for the evaluation study.

FINANCIAL BID EVALUATION

- A. The Bid without valid Earnest Money Deposit will not be considered.
- B. The Bidder with lowest financial bid (L1) will be awarded the evaluation study.
- C. Only fixed price financial bids indicating total price for all the deliverables and services specified in this bid document will be considered.
- D. The bid price in INR should include all taxes & levies.
- E. Any conditional bid would be rejected.
- F. If a firm quotes NIL charges/consideration, the bid shall be treated as unresponsive and will not be considered.
- G. Errors & Rectification: Arithmetical errors will be rectified on the following basis: "If there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price shall prevail and the total price shall be corrected. If there is a discrepancy between words and figures, the amount in words will prevail".

APPOINTMENT OF SUCCESSFUL BIDDER

Award Criteria

PLANNING DEPARTMENT, GNCTD will award the evaluation study to the successful bidder.

Right to Accept Any Proposal and To Reject Any or All Proposal(s)

PLANNING DEPARTMENT, GNCTD reserves the right to accept or reject any proposal, and to annul the tendering process and reject all proposals at any time prior to award of contract, without thereby incurring any liability to the affected bidder or bidders or any obligation to inform the affected bidder or bidders of the grounds for PLANNING DEPARTMENT, GNCTD action.

Performance Guarantee

PLANNING DEPARTMENT, GNCTD will require the selected bidder to provide an irrevocably, unconditionally Performance Bank Guarantee, within 15 days from the Notification of award, for a value equal to 10% of total contract value. The Performance Guarantee shall contain a claim period of sixty days beyond the date of completion of all contractual obligations. The selected bidder shall be responsible for extending the validity date and claim period of the Performance Guarantee as and when it is due on account of non-completion of evaluation study. In case the selected bidder fails to submit performance guarantee within the time stipulated, PLANNING DEPARTMENT, GNCTD at its discretion may cancel the order placed on the selected bidder without giving any notice. Chapter 4: Specifications and allied technical details

1. OBJECTIVE OF SURVEY

Prime objective of the study is to assess the effective use of the facilities provided by the government by the senior citizens, capacity utilization and the quality of services /socio-cultural activities provided in the centres. Also, the benefits/outcome of the services in terms of its impact on the well being of the beneficiaries is also to be evaluated.

2. METHODOLOGY FOR SURVEY

As per the information provided by Department of Social Welfare, at present 108 recreation centres (exclusively for senior citizens) are getting grant in Delhi. To assess the utility of these centres from senior citizen point of view for passing their leisure time through social interaction, entertainment, reading books etc. two types of schedules are designed. One schedule is for obtaining views/feedback of beneficiaries i.e. senior citizens attending the recreation centre on the day of survey and another schedule is for in-charge closely associated with functioning of recreation centre. Besides this an observational schedule is also designed for getting the number of senior citizens availing the services of recreation centre on the day of survey during Morning/Noon/Evening hours. The photo of all centres will be taken during the survey and must be added in the report of evaluation study.

3. SAMPLING DESIGN

All 108 recreation Centres for senior citizens will be surveyed. At each Centre the All 108 recreation Centres for senior citizens will be surveyed. At each Centre the schedule for incharge will be canvassed and another schedule will be canvassed with randomly selected 10 beneficiaries/senior citizens. At each recreation Centre, 10 beneficiaries will be canvassed randomly in the following manner:

Total 10 beneficiaries will be covered, if however, any of the beneficiary falls short in any age aroup than shortfall may be completed from another age-group mentioned above.

5. SCHEDULES FOR SURVEY

Two types of schedules are prepared. Schedule I is for In-charge of Recreation Centre, who is closely associated with its functioning and is well aware of all implementation aspects of this scheme. The purpose of this schedule is to get feedback about source of resources for running the centres, availability of basic facilities, recreation services etc. Schedule II is meant for the beneficiaries/senior citizens availing the services of recreation centres to get their views about the type & quality of services available therein and their suggestions for improving utilization of such facilities. In addition, an Observational Schedule is also designed to know the quantum of beneficiaries- age-wise, sex-wise attending the recreation centre throughout the day of survey during morning/noon/evening hours.

Chapter 5: Price Schedule






