Cancellation of Candidature for the post of Statistical Assistant

Whereas, Sh. AJAY KUMAR PATEL, D.O.B:- 30-11-1993 (Roll No. 230601203001168) has been nominated by DSSSB to Planning Department, GNCTD for appointment to the post of Statistical Assistant (Post Code - 60/23) in Planning & Statistical Cadre, GNCTD vide letter No.F.1(748)/P&PII/DSSSB/2023/2153 dated 11.09.2024..

And Whereas, Sh. AJAY KUMAR PATEL was called for verification of the correctness of the information/documents as furnished in the application forms and e-dossier vis-à-vis the original documents on 21.09.2024 vide email dated 19.09.2024 on his registered email id (ajay301193@gmail.com) and he reported on the scheduled date for the same.

And Whereas, on primary scrutiny of the e-dossier and the documents submitted by Sh. AJAY KUMAR PATEL during verification process in Planning Department, it was found that he possess OBC Certificate which was issued by Govt. of Uttar Pradesh which does not fulfill the requisite conditions of Reservation benefits stipulated in the advertisement for OBC (Delhi) for appointment to the post of Statistical Assistant.

And Whereas, the case of Sh. AJAY KUMAR PATEL was placed before the Committee constituted vide Planning Department dated 04.02.2025 for assessment of the eligibility of Sh. AJAY KUMAR PATEL and the Committee recommended that he is ineligible for the post of Statistical Assistant (60/23) as he do not fulfill the requisite conditions stipulated under Reservation Benefits in the advertisement for OBC (Delhi) i.e. clause 6 (iv) and (v).

Now, therefore, in view of the above facts, the candidature of Sh. AJAY KUMAR PATEL for the post of Statistical Assistant (Post Code – 60/23) is hereby cancelled and his dossier is returned to DSSSB.

Whereas, Ms. SAKSHI, D.O.B:- 07.10.2001 (Roll No. 230601203000187) has been nominated by DSSSB to Planning Department, GNCTD for appointment to the post of Statistical Assistant (Post Code - 60/23) in Planning & Statistical Cadre, GNCTD vide letter No.F.1(748)/P&PII/DSSSB/2023/2153 dated 11.09.2024..

And Whereas, Ms. SAKSHI was called for verification of the correctness of the information/documents as furnished in the application forms and e-dossier vis-à-vis the original documents on 22.09.2024 vide email dated 19.09.2024 on her registered email id (sakshisankroud@gmail.com) and she reported on the scheduled date for the same.

And Whereas, on primary scrutiny of the e-dossier and the documents submitted by Ms. SAKSHI during verification process in Planning Department, it was found that she possess OBC Certificate which was issued by Govt. of Uttar Pradesh which does not fulfill the requisite conditions of Reservation benefits stipulated in the advertisement for OBC (Delhi) for appointment to the post of Statistical Assistant.

And Whereas, the case of Ms. SAKSHI was placed before the Committee constituted vide Planning Department dated 04.02.2025 for assessment of the eligibility of Ms. SAKSHI and the Committee recommended that she is ineligible for the post of Statistical Assistant (60/23) as she do not fulfill the requisite conditions stipulated under Reservation Benefits in the advertisement for OBC (Delhi) i.e. clause 6 (iv) and (v).

Now, therefore, in view of the above facts, the candidature of Ms. SAKSHI for the post of Statistical Assistant (Post Code - 60/23) is hereby cancelled and her dossier is returned to DSSSB.

And Whereas, Sh. PRADEEP KUMAR was called for verification of the correctness of the information/documents as furnished in the application forms and e-dossier vis-à-vis the original documents on 23.09.2024 vide email dated 19.09.2024 on his registered email id (pradeep85389@gmail.com) and he reported on the scheduled date for the same.

And Whereas, on primary scrutiny of the e-dossier and the documents submitted by Sh. PRADEEP KUMAR during verification process in Planning Department, it was found that he possess OBC Certificate which was issued by Govt. of Bihar which does not fulfill the requisite conditions of Reservation benefits stipulated in the advertisement for OBC (Delhi) for appointment to the post of Statistical Assistant.

And Whereas, the case of Sh. PRADEEP KUMAR was placed before the Committee constituted vide Planning Department dated 04.02.2025 for assessment of the eligibility of Sh. PRADEEP KUMAR and the Committee recommended that he is ineligible for the post of Statistical Assistant (60/23) as he do not fulfill the requisite conditions stipulated under Reservation Benefits in the advertisement for OBC (Delhi) i.e. clause 6 (iv) and (v).

Whereas, Sh. HARIOM KUSHWAHA, D.O.B:- 26.12.1999 (Roll No. 230601204000228) has been nominated by DSSSB to Planning Department, GNCTD for appointment to the post of Statistical Assistant (Post Code - 60/23) in Planning & Statistical Cadre, GNCTD vide letter No.F.1(748)/P&PII/DSSSB/2023/2153 dated 11.09.2024.

And Whereas, Sh. HARIOM KUSHWAHA was called for verification of the correctness of the information/documents as furnished in the application forms and e-dossier vis-à-vis the original documents on 21.09.2024 vide email dated 19.09.2024 on his registered email id (1999hariomkushwaha@gmail.com) and he reported on the scheduled date for the same.

And Whereas, on primary scrutiny of the e-dossier and the documents submitted by Sh. HARIOM KUSHWAHA during verification process in Planning Department, it was found by the committee that he belongs to community which is recognized as OBC in the state of Uttar Pradesh.

Whereas another committee was constituted vide order dated 04.02.2025 and committee meeting held on 10.02.2025. The committee considered the case and observed that the applicant has applied under the category OBC (D) in his application form. Further, the OBC certificate of the candidate has been issued by the office of District Magistrate Rohini, North West District, thereby stating that "Certificate No. 90500000299587, this is to certify that HARIOM KUSHWAH s/o DEVI PRASAD KUSHWAH r/o PLOT NO. 16B YOGI RAJ PURAM RANI KHERA RANIKHERA DELHI 110081 INDIA belongs to the KOERI community of UTTAR PRADESH state which is recognised as Other Backward Class"

Further, the NCL Certificate dated 21.06.2023 issued by Office of the Executive Magistrate (Dwarka) also states that "It is stated that OBC Certificate bearing No. 90500000299587 dated 12.08.2017 was issued in favour of Mr. HARIOM KUSHWAH s/o DEVI PRASAD KUSHWAH r/o PLOT NO. 16B YOGI RAJ PURAM RANI KHERA RANIKHERA DELHI 110081 INDIA belongs to the KOERI caste which is recognised as Other Backward Class in the state of UTTAR PRADESH."

Whereas the above stated certificates clearly state that the candidate belongs to KOERI community recognised as OBC in the State of Uttar Pradesh. Although the certificates are issued by the Revenue Department of the GNCT of Delhi, yet both the certificates do not qualify to be OBC (D) as stipulated in the conditions of the reservation benefits mentioned in the Advt. for the post code 60/23. Hence, the

certificate of the candidate does not fulfil both the conditions stipulated under Reservation Benefits i.e. clause 6 (v) (A) (B).

Now, therefore, in view of the above facts, the candidature of Sh HARIOM KUSHWAHA for the post of Statistical Assistant (Post Code - 60/23) is hereby cancelled and his dossier is returned to DSSSB.

Whereas, Sh. HARIOM BHARATI, D.O.B:-28.01.1993 (Roll No. 230601203000343) has been nominated by DSSSB to Planning Department, GNCTD for appointment to the post of Statistical Assistant (Post Code - 60/23) in Planning & Statistical Cadre, GNCTD vide letter No.F.1(748)/P&PII/DSSSB/2023/2153 dated 11.09.2024.

And Whereas, Sh. HARIOM BHARATI was called for verification of the correctness of the information/documents as furnished in the application forms and e-dossier vis-à-vis the original documents on 23.09.2024 vide email dated 19.09.2024 on his registered email id (bharatihariom@gmail.com) and he reported on the scheduled date for the same.

And Whereas, on primary scrutiny of the e-dossier and the documents submitted by Sh. HARIOM BHARATI during verification process in Planning Department, it was found by the committee that he belongs to community which is recognized as OBC in the state of Bihar.

Whereas another committee was constituted vide order dated 04.02.2025 and committee meeting held on 10.02.2025. The committee considered the case and observed that the applicant has applied under the category OBC (D) in his application form. Further, the OBC certificate of the candidate has been issued by the office of District Magistrate DWARKA, South West District thereby stating that "Certificate No. 90500000686793, this is to certify that HARI OM BHARTI s/o RAMESH BHARTI r/o House No -29 MS BLOCK NEAR GOVT SCHOOL MOHAN GARDEN UTTAM NAGAR DELHI 110059 INDIA belongs to the KUSHWAHA (KOERI) community of BIHAR state which is recognised as Other Backward Class"

Further, the NCL Certificate dated 21.06.2023 issued by Office of the Executive Magistrate (Dwarka) also states that "It is stated that OBC Certificate bearing No. 90500000686793 dated 18.11.2020 was issued in favour of Mr. HARI OM BHARTI s/o RAMESH BHARTI r/o House No -29 MS BLOCK NEAR GOVT SCHOOL MOHAN GARDEN UTTAM NAGAR DELHI 110059 INDIA belongs to the KUSHWAHA (KOERI) caste which is recognised as Other Backward Class in the state of BIHAR"

Whereas the above stated certificates clearly states that the candidate belongs to KUSHWAHA (KOERI) community recognised as OBC in the State of BIHAR. Although the certificates are issued by the Revenue Department of the GNCT of Delhi, yet both the certificates do not qualify to be OBC (D) as stipulated in the conditions of the reservation benefits mentioned in the Advt. for the post code 60/23. Hence, the

certificate of the candidate does not fulfil both the conditions stipulated under Reservation Benefits i.e. clause 6 (v) (A) & (B).

Whereas, the deficiency memo dated 23.09.2024 was issued to the candidate to produce the OBC (D) Certificate. In response, the candidate has submitted certificate No. 90500001203855 dated 14.10.2024 issued by office of District Magistrate DWARKA, South West District which stipulates that "this is to certify that HARI OM BHARTI s/o RAMESH BHARTI r/o House No -29 MS BLOCK NEAR GOVT SCHOOL MOHAN GARDEN UTTAM NAGAR DELHI 110059 INDIA belongs to the KOERI which is recognised as the other backward class under the Govt. of NCT of Delhi."

Whereas the above stated certificate clearly state that the candidate belongs to KOERI community which is recognised as OBC under the Govt. of NCT of Delhi, but the instant certificate is issued on 14.10.2024 which is after the cut-off date of the advertisement i.e. 15.09.2023. Hence this candidate also does not fulfil the conditions stipulated under Reservation Benefits i.e. clause 6 (iii).

Now, therefore, in view of the above facts, the candidature of Sh HARIOM BHARATI for the post of Statistical Assistant (Post Code – 60/23) is hereby cancelled and his dossier is returned to DSSSB.
