ORDER

Cancellation of Candidature for the post of Statistical Assistant

Whereas, Sh. Ravi Kumar, D.O.B. 06-07-1990 (Roll No.12332201342) has been nominated by DSSSB to Planning Department, GNCTD for appointment to the post of Statistical Assistant (Post Code - 04/17) in Planning & Statistical Cadre, GNCTD vide letter No.F.1(346)/DSSSB/P&P/2017/4817 dated 04.03.2021.

And Whereas, Sh. Ravi Kumar was called for verification of the correctness of the information/documents as furnished in the application forms and e-dossier vis-à-vis the original documents on 01-04-2021 and he reported on the scheduled date for the same.

And Whereas, Sh. Ravi Kumar was nominated for appointment to the post of Statistical Assistant in Development Department, GNCTD vide Cadre Controlling Unit, Planning Department Order No.22/2020 dated 20.05.2021 with the approval of Competent Authority.

And Whereas, Sh. Ravi Kumar did not accept the offer of appointment even after subsequent reminders and hence, Development Department, GNCTD has cancelled the candidature of Sh.
