## Cancellation of Candidature for the post of Statistical Assistant

Whereas, Ms. Deepshikha, D.O.B. 28.09.1992 (Roll No.12322200606) has been nominated by DSSSB to Planning Department, GNCTD for appointment to the post of Statistical Assistant (Post Code - 04/17) in Planning & Statistical Cadre, GNCTD vide letter No.F.1(346)/P&P/17/DSSSB/4127-4130 dated 08.10.2020.

And Whereas, Ms. Deepshikha was called for verification of the correctness of the information/documents as furnished in the application forms and e-dossier vis-à-vis the original documents on 23.10.2020 vide email dated 22.10.2020 on her registered email id (Deepshikha.jaiswal17@gmail.com) and she reported on the scheduled date for the same.

And Whereas, on primary scrutiny of the e-dossier and the documents submitted by Ms. Deepshikha during verification process in Planning Department, it was found that the date of passing Post Graduation Degree by the candidate is after the cutoff date for determining eligibility i.e. 21.08.2017 as per advertisement of recruitment dated 18.07.2017.

And Whereas, the case of Ms. Deepshikha was placed before the Committee constituted vide Planning Department Order No.24/2021 dated 09.06.2021 for reassessment of the eligibility of such candidates and the Committee recommended that the date of passing Post Graduation Degree by Ms. Deepshikha (Roll No.12322200606) is 21.02.2020 which is after the cut off date for determining eligibility i.e. 21.08.2017 therefore, she is ineligible for the post of Statistical Assistant (04/17).

Now, therefore, in view of the above facts, the candidature of Ms. Deepshikha for the post of Statistical Assistant (Post Code – 04/17) is hereby cancelled and her dossier is returned to DSSSB.
