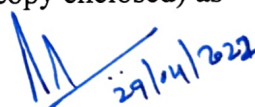
OFFICE MEMORANDUM

Subject: Submission of Immovable Property Return for the year 2021 under CCS (Conduct) Rules, 1964 in respect of the officers/officials of Planning & Statistical Cadre, GNCTD.

In terms of Rule 18 of **CCS (Conduct) Rules, 1964** every Government servant belonging to any service or holding any post including Group-A and Group-B, is required to furnish the Immovable Property Return in such form as may be prescribed by the Government, giving full particulars regarding the immovable property inherited by him or owned or acquired by him on lease or mortgage, either in his own name or in the name of any member of his family or in the name of any other person.

In this regard, the undersigned is directed to invite attention to the DoPT's O.M. No.26/1/2018-CS.I (PR/CMS) dated 21.12.2021 vide which instruction for timely submission of Immovable Property Return (IPR) were circulated.

It is, therefore, requested to the concerned officers/officials of Planning & Statistical Cadre, Govt. of NCT of Delhi, may be directed to submit their Immovable Property Return (IPR) for the year 2021 to Cadre Controlling Unit, Planning Department, Govt. of NCT of Delhi, giving complete details in every column of the prescribed proforma (copy enclosed) as earliest possible.
