Cancellation of Candidature for the post of Statistical Assistant

Whereas, Sh. Jaswant Singh, D.O.B. 28.12.1988 (Roll No.11202200208) has been nominated by DSSSB to Planning Department, GNCTD for appointment to the post of Statistical Assistant (Post Code - 04/17) in Planning & Statistical Cadre, GNCTD vide letter No.F.1(346)/P&P/17/DSSSB/4127-4130 dated 08.10.2020.

And Whereas, Sh. Jaswant Singh was called for verification of the correctness of the information/documents as furnished in the application forms and e-dossier vis-à-vis the original documents on 21.10.2020 vide email dated 19.10.2020 on his registered email id (Singh.Jaswant309@gmail.com) and he reported on the scheduled date for the same.

And Whereas, on primary scrutiny of the e-dossier and the documents submitted by Sh. Jaswant Singh during verification process in Planning Department, it was found that the date of passing of Post Graduation Degree by the candidate is after the cutoff date for determining eligibility i.e. 21.08.2017 as per advertisement of recruitment dated 18.07.2017.

And Whereas, the case of Sh. Jaswant Singh was placed before the Committee constituted vide Planning Department's Order No.24/2021 dated 09.06.2021 for reassessment of the eligibility of such candidates and the Committee recommended that the date of passing Post Graduation Degree by Sh. Jaswant Singh (Roll No.11202200208) is 04.09.2017 which is after the cut off date for determining eligibility i.e. 21.08.2017 therefore, he is ineligible for the post of Statistical Assistant (04/17).

Now, therefore, in view of the above facts, the candidature of Sh. Jaswant Singh for the post of Statistical Assistant (Post Code - 04/17) is hereby cancelled and his dossier is returned to DSSSB.
