- 2. The above mentioned officers shall be eligible for exercising option, if any, under the provisions of FR-22, CCS (Revised Pay) Rules and GoI's orders there under. However, option, if any, shall be exercised within one month from the date of issue of order.
- The above promotions shall be subject to the following court cases:
- (i) The final outcome in Original Application No. 118/2018 filed by Sh. Samir Chharchholia & Ors. Vs. Govt. of NCT of Delhi.
- (ii) The directions of Hon'ble CAT in M.A. 2305/2023 in O.A. No. 2113/2022 in the matter of Sh. Sunil Kumar & Ors. Vs. Govt. of NCT of Delhi.
- 4. Consequent upon their promotion to the post of Statistical Officer(Plg./Stats.), the officers mentioned in Table-I are hereby Stand Relieved w.e.f. <u>28.12.2023(A/N)</u> with the direction to join in Cadre Controlling Unit of Planning Department, GNCTD.
- 5. The Head of Department of the above officers shall ensure that the aforesaid officials are clear from vigilance angle as per the instructions contained in DoPT OM No. 22011/4/91-Estt.(A) dated 14/09/1992 & other related OMs. Further, it may also be ensured that no penalty is in operation against the aforesaid officers. If any of the officials is not clear from vigilance angle or his/her integrity is not certified, the same should be brought to the notice of Cadre Controlling Unit, Planning Department immediately. An undertaking shall also be obtained by the concerned HoDs from the promoted officials that no disciplinary/ criminal proceedings are pending/ contemplated against them.
- 6. Transfer of Sh. Gaurav Varshney, Statistical Officer from Planning Department to Transport Department ordered vide Order No.- 14/2023 dated 12.09.2023 (at Sl No.-5, Table III) is hereby cancelled ab-initio. Rest of the contents of the order remains the same.
- 7. All the officers, except Sh. Gaurav Varshney (S.No. 5, Table-III), who have not complied with the order No. 14/2023 dated 12.09.2023 are hereby "STAND RELIEVED" w.e.f. 28.12.2023 (A/N) subject to ensuring by the concerned HoDs where the officers are presently posted that all the conditions mentioned in the order dated 12.09.2023 are satisfied and the officers are clear from vigilance angle. In case, any vigilance case is pending/ contemplated against the concerned officers, the same shall be intimated to this department within 03 days.
