ORDER

Cancellation of Candidature for the post of Statistical Assistant

Whereas, Ms. Pooja Gayatri D.O.B. 24.10.1994 (Roll No.11302200056) has been nominated by DSSSB to Planning Department, GNCTD for appointment to the post of Statistical Assistant (Post Code - 04/17) in Planning & Statistical Cadre, GNCTD vide letter No.F.1(346)/P&P/17/DSSSB/4127-4130 dated 08.10.2020.

And Whereas, Ms. Pooja Gayatri was called for verification of the correctness of the information/documents as furnished in the application forms and e-dossier vis-à-vis the original documents on 23.10.2020 vide email dated 22.10.2020 on her registered email id (Poojagayatri94@gmail.com) and she reported on the scheduled date for the same.

And Whereas, Ms. Pooja Gayatri was nominated for appointment to the post of Statistical Assistant in Department of Trade & Taxes, GNCTD vide Cadre Controlling Unit, Planning Department Order No.27/2020 dated 14.12.2020 with the approval of Competent Authority.

And Whereas, Ms. Pooja Gayatri did not accept the offer of appointment even after subsequent reminders and hence, Department of Trade & Taxes, GNCTD has cancelled the candidature of Ms. Pooja Gayatri (Roll No.11302200056) for the post of Statistical Assistant vide their Memorandum dated F.VI/01/T&T/HR/Rectt./SA/2020/6367-370 dated 29.07.2021.

Now, therefore, in view of the above facts, the candidature of Ms. Pooja Gayatri for the post of Statistical Assistant (Post Code - 04/17) is hereby cancelled and her dossier is returned to DSSSB.
