Subject: Updation of Educational Qualifications of Planning and Statistical Cadre Officers-reg

Madam / Sir,

The Planning and Statistical Cadre Officers are working in various departments, hospitals, and directorates of the GNCTD. This is to inform you that the Cadre Controlling Unit (CCU), Planning Department, GNCTD, will be initiating the regular promotion process for the Vacancy Year 2025 and 2026 during the current calendar year. As per the Recruitment Rules, possession of a postgraduate degree is an essential qualification for promotion to the post of Assistant Director. However, it has been observed that several officers currently lack this requisite qualification.

2. In accordance with the "Model Calendar for Conducting Departmental Promotion Committees (DPCs)", the last date for sending a complete proposal, along with relevant Recruitment/Service Rules, to the UPSC is 15th April of the year preceding the vacancy year. To align with the DPC timeline, it is crucial to update and maintain accurate records of the educational qualifications of all officers.

Process for Updation of Educational Qualification:

i. Action by Administrative Department:

a) The Administrative Department of the concerned officers is requested to verify and update the educational qualifications of officers in their respective Service Books. Duly verified and certified, it must clearly state that the additional educational qualification has been updated in the Service Records/Books.

ii. Submission to Cadre Controlling Unit:

a) The Administrative Department shall forward the copy of first page of updated and certified Service Book to the Cadre Controlling Unit, Planning Department, GNCTD, for necessary updation in the seniority list and other related records.

iii. Responsibility for Compliance:

Please note that the onus lies entirely with the Administrative Department to ensure:

- a) Timely verification and updation of educational qualifications in the Service Books of the officers.
- b) Submission of the copy of first page of updated and certified Service Book to the CCU.
- c) Additionally, any request made directly by officers, without routing through the proper channel/Administrative Department, will not be entertained.
- 3. Timely compliance with this process will facilitate the smooth conduct of DPCs and adherence to the stipulated timelines.

4. Officials who have acquired the necessary qualifications as per the Recruitment Rules by December 2024, or are expected to complete them by December 2025, are requested to Intimate the same at planning.ccu.delhi@gmail.com to facilitate the necessary formalities with the Administrative Department.

In light of the above, it is requested to kindly expedite the submission of the required details, along with supportive documents, to ensure the timely promotion for the aforementioned vacancy years.
