Cancellation of Candidature for the post of Statistical Assistant

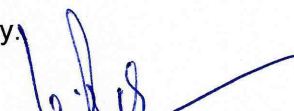

Vijay Kumar Pal was called for verification of the correctness of the information/documents as furnished in the application forms and e-dossier vis-à-vis the original documents on 21.10.2020 vide email dated 19.10.2020 on his registered email id (Vijaycesp@gmail.com) and he reported on the scheduled date for the same.

And Whereas, Sh. Vijay Kumar Pal was nominated for appointment to the post of Statistical Assistant in Department of Food, Supplies & Consumers Affairs, GNCTD vide Cadre Controlling Unit, Planning Department Order No.27/2020 dated 14.12.2020 with the approval of Competent Authority.

And Whereas, Sh. Vijay Kumar Pal has submitted his unwillingness to join the post of Statistical Assistant in Department of Food, Supplies & Consumers Affairs, GNCTD and hence, Department of Food, Supplies & Consumers Affairs, GNCTD has cancelled the candidature of Sh. 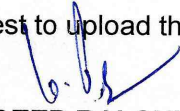
