ORDER No. 43 /2025

In continuation of this Department's Order Nos. 15/2024, 17/2024 and 30/2024, and on the recommendations of the Union Public Service Commission (UPSC), the Hon'ble Lieutenant Governor, Delhi is pleased to promote Shri Shahid Khan, presently working as Statistical Officer, Group 'B' Gazetted, in the Pay Matrix Level-7, to the post of Assistant Director (Planning/Statistics), Group 'A' Gazetted, in the Pay Matrix Level-10 under the 7th CPC, along with other admissible allowances, on regular basis with immediate effect and notionally w.e.f. 27.06.2024.


2. Consequent upon his promotion, Shri Shahid Khan is hereby transferred / posted to the Planning Department against a vacant post, with immediate effect.

3. The promotion shall be subject to outcome of further orders that may be passed by the Hon'ble Supreme Court in the case of Jarnail Singh & Ors (Civil Appeal No. 629 of 2022) arising out of SLP(C) No. 30621/2011) as conveyed by the DoPT vide O.M No. 36012/16/2019-Estt. (Res.) dated 12.04.2022. Further, the promotion shall also remain subject to the final outcome of the Original Application No. 4554/2015 filed by Shri Ashutosh Kumar & Ors. Vs. Govt. of NCT of Delhi, OA No. 757/2024 filed by Shri Thakur Dayal Vs. Govt. of NCT of Delhi & Others and OA No. 100/1210/2024 filed by Ms. Kavita Vs. Govt. of NCT of Delhi & others in the Principal Bench of CAT, New Delhi.

4. The above-mentioned officer may exercise option with regard to fixation of pay, if any, as per FR-22 and GoI's orders issued thereunder.

5. The concerned HoD should ensure that the promoted officer is clear from the vigilance angle before his actual relieving to join the post of Assistant Director, as per instructions contained in DoPT OM No. 22011/4/91-Estt.(A) dated 14.09.1992 and other related OMs. Further, it may also be ensured that no penalty is in operation before relieving the above officer to assume his duties as Assistant Director (Plg./Stats.). If the promoted officer is found to be not clear from the vigilance angle or his integrity is not certified, the same shall be brought to the notice of the Cadre Controlling Unit, Planning Department, immediately for further necessary action in the matter.
