While allowing **O.A. No. 1646/2027** titled "**Rohit Vs. Govt. of NCT of Delhi & Ors**", the Hon'ble Central Administrative Tribunal (CAT); Principal Bench, New Delhi In its final order dated 08.11.2024 directed as follows:-

"12. We are of the considered opinion that injustice has been done to the applicant, He deserves to be appointed as Statistical Assistant from the date when his other colleagues from the Result list Post Code No.66/14, Advertisement No.1/14 were appointed. Needless to say, he will be granted all the notional benefits of seniority etc., however, without any back wages."

2. Now, therefore, in compliance with the aforesaid judgment and in order to give effect to the directions of the Hon'ble CAT, Delhi, and with the approval of the Chief Secretary, Delhi, the undersigned hereby orders the following: -

(i) The notional appointment of Shri Rohit, presently working as Statistical Assistant and posted in the Environment Department, GNCTD, w.e.f. 05.09.2016, being the date on which his immediate junior/colleague from the same result list (Post Code No. 66/14) joined the post.;

(ii) To carry out necessary changes in service records of Sh. Rohit, Statistical Assistant, to align the Hon'ble CAT Judgment.
