2. These activities include the implementation of the 8th Economic Census, National Sample Survey (NSS), Annual Survey of Unincorporated Sector Enterprises (ASUSE), Periodic Labour Force Survey (PLFS), and other socio-economic surveys/statistical works assigned by MoSPI from time to time.
