**ORDER NO. 06/2025**

On the recommendations of the Union Public Service Commission (UPSC), the Hon'ble Lt. Governor, Delhi is pleased to promote Sh. C. K. Dutta (DOB: 31.03.1973), Joint Director (Plg/Stat), Group 'A' Gazetted in the pay scale of Level 12 to the post of Director (PES) in the pay scale of Level 13 in Planning & Statistical Cadre, GNCTD on regular basis with immediate effect.


2. Consequent upon his promotion to the post of Director (PES), Group 'A' Gazetted, in the Pay Scale of Level-13 in the Planning & Statistical Cadre, Govt. of NCT of Delhi, with immediate effect, he shall remain posted on the cadre strength in the Cadre Controlling Unit, Planning Department, GNCTD, against the vacant post of Director (PES) until his posting on the post of Director (PES) is finalized by the NCCSA.

3. The promotion of Sh. C. K. Dutta shall be subject to the following conditions:

a) The above-mentioned officer shall be eligible for exercising an option, if any, under the provisions of FR-22, CCS (Revised Pay) Rules and Govt's orders thereunder.

b) As per para 12.3 of DoPT OM dated 22.07.2024, the Head of Department where the promoted official is currently posted should ensure that the promoted officer is clear from vigilance angle before his actual relieving to join the post of Director (PES) as per the instructions contained in DoPT OM No. 22011/4/91-Estt.(A) dated 14/09/1992 & other related OMs. Further, it may also be ensured that no penalty is in operation before relieving above officer to assume his duties as Director (PES). If the promoted officer is found to be not clear from vigilance angle or his integrity is not certified, the same shall be brought to the notice of Cadre Controlling Unit, Planning Department immediately for further necessary action in the matter. An undertaking may also be obtained by the concerned HoD from the promoted officer that no disciplinary/ criminal proceedings are pending/ contemplated against him.
