**ORDER NO. 17/2024**

Govt. of NCT of Delhi & Others in the Principal Bench of CAT, New Delhi.

5. These officers may exercise their option with regard to fixation of pay, if any, as per FR-22 within one month of issue of this order. The concerned Head of the Departments shall ensure that no disciplinary/criminal proceedings are pending and no penalty is in operation against any of the above mentioned officers, before relieving them to take up their new assignment on promotion. If any officer, is not clear from vigilance angle the same shall be brought to the notice of this department immediately.
