Subject: Order in compliance with the Order of the Hon'ble Central Administrative Tribunal (CAT), Principal Bench, New Delhi, dated 27.11.2024 in OA 1210 of 2024 titled Kavita vs. Govt. of NCT of Delhi & Ors, MA 425 of 2025 in the OA 1210 of 2024.

While allowing O.A. No. 1210/2024 titled "Kavita Vs. Govt. of NCT of Delhi & Ors" and MA 425 of 2025 in the said O.A. No. 1210/2024, the Hon'ble Central Administrative Tribunal (CAT), Principal Bench, New Delhi orders as follows:-

#### Orders of the Hon'ble Central Administrative Tribunal

# In its final order dated 27.11.2024 in O.A. No. 1210/2024

" 27. The impugned order of 30.01.2024 reverting the applicant to the lower post of Statistical Assistant is quashed and set aside. The respondents are directed to restore the promotion of the applicant as a Statistical Officer. Further, since the applicant has already completed the required service on the promotional post. She will be deemed fit for consideration for promotion as Assistant Director (Group 'A') w.e.f. the due date when she became eligible that is w.e.f. 01.01.2023."

# In its order dated 30.01.2025 in MA 425 of 2025 in the O.A. No. 1210/2024

"3. The OA No. 1210/2024 was allowed on the said date. In addition to the terms as specified therein, the respondents are further directed to consider the consequential benefits of the applicant as per law."
