- 3. The recommendations of the DPC are subject to the final outcome of the Original Application No. 4554/2015 filed by Sh. Ashutosh Kumar & Ors. Vs. Govt. of NCT of Delhi and outcome of the pending court cases in terms of DOP&T OM No. in 36012/16/2019-Est. (Res.) dated 12.04.2022 issued in pursuance of judgment dated 28.01.2022 of the Hon'ble Supreme Court of India Jairnal Singh & Ors. in Civil Appeal No. 629 of 2022 arising out of SLP 2011, (C) No. 30621.
- 4. The above mentioned officers shall be eligible for exercising option, if any, under the provisions of FR-22, CCS (Revised Pay) Rules and Gol's orders there under. However, options, if any, shall be exercised within one month from the date of issue of order.
- 5. The transfer in r/o Ms. Padma vide Order No. 04/2023 dated 17.02.2023 is hereby cancelled. Rest of the contents of the said order remains the same.
